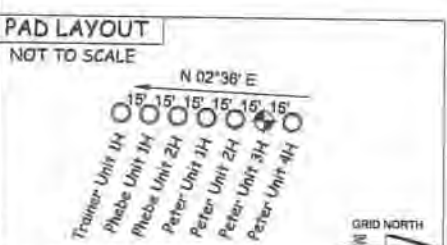
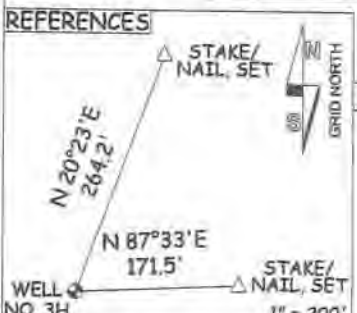


NOTES

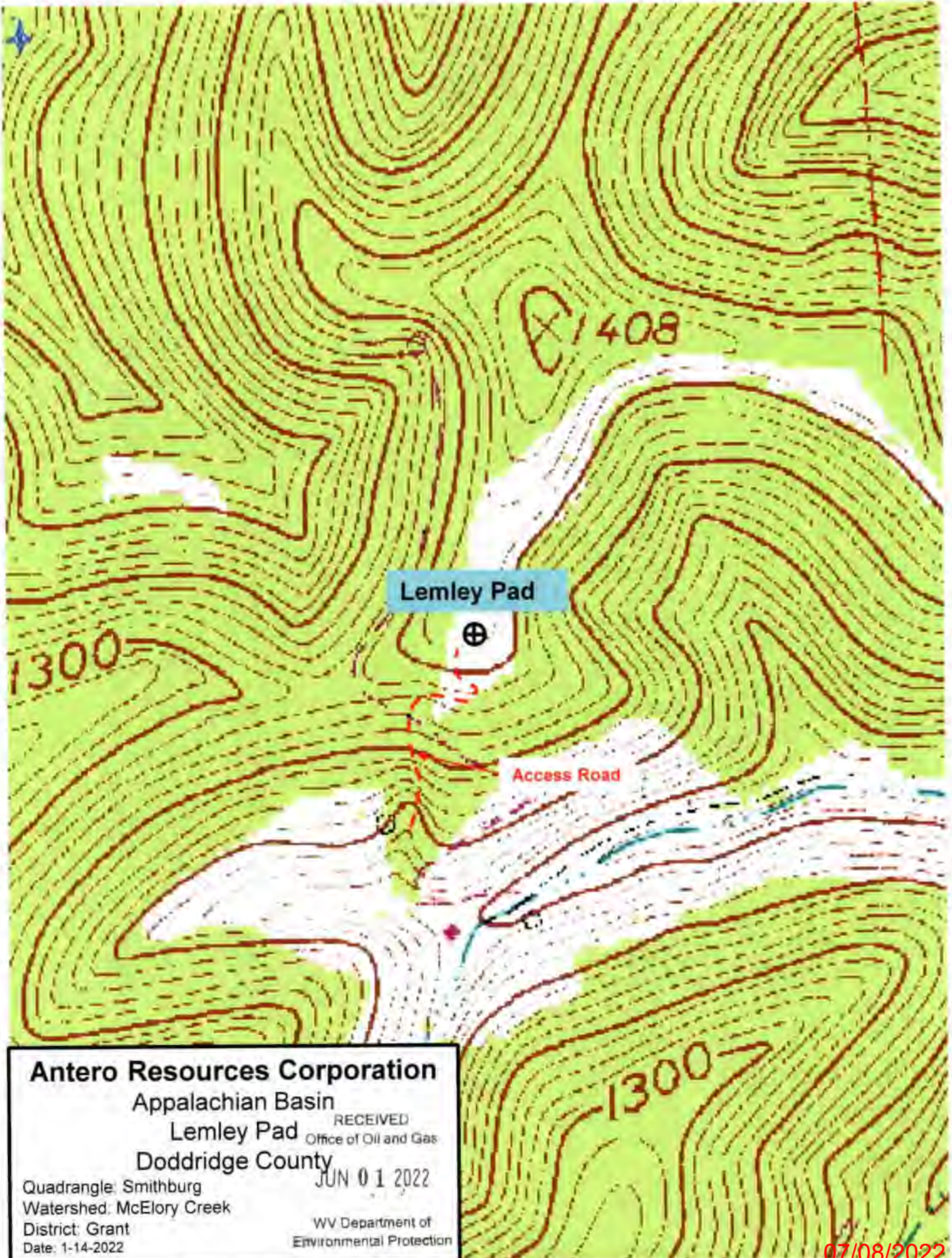
