This well is open topped 8.875" that has been measured to a depth of 217'. Upon running the camera, it shows the casing stops at 215' and the hole is dry to TD.

Due to the construction, depth and Landowners concerns of slip potential we propose plugging this well/ mine through the following procedure:

- A. Clear a walking path to the wellsite and small brush directly around the well.
- B. Run 225' 1.25" SDR7 plastic gas line to the well and install a tee with a valved clean up bypass at the wellhead and a valve to control the cement going down the pipe placed into well bore. The 1.25" SDR7 plastic gas line will be ran in the well/mine to a depth just above 217'.
- C. Pump cement volume to fill from 217' to 20' (approximately 74 sks at 1.14 yield, 15bbl of Class A/ Class L cement)
- D. Clean up lines and dispose of clean up water.
- E. Remainder of casing volume to be topped off with Sakrete and install monument.
