MIKE MITCHELL and **KEVIN S. WRIGHT** being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 19th day of June, 2013 and that the well was plugged in the following manner:

Formation	Filling Material	Casing Size & Kind	Casing Pulled	Casing Left In
Cleaned 12 1/4' hole from the surface to 328'. Reduced hole to 9 7/8". Cleaned 9 7/8" hole from 328' to 1260'. Reduced hole to 6 1/4". Cleaned 6 1/4" hole from 1260' to 1263'. Cleaned 9 7/8" hole through the Pittsburgh Coal seam from 920' to 929'. <u>Cemented hole from 1263' back to surface as follows:</u> From 1263' to 1129' with Expandable Cement. From 1129' to 820' with 180 sacks of Thixotropic Cement w/ dye. From 820' to surface with Expandable Cement. A total of 480 sacks of Expandable Cement and 180 sacks of Thixotropic Cement was used to cement the hole from 1263' to the surface. Cement did circulate at the surface. Left 19' of 16" conductor casing in the hole from the surface to 19'.	16" Conductor	0'	19'
