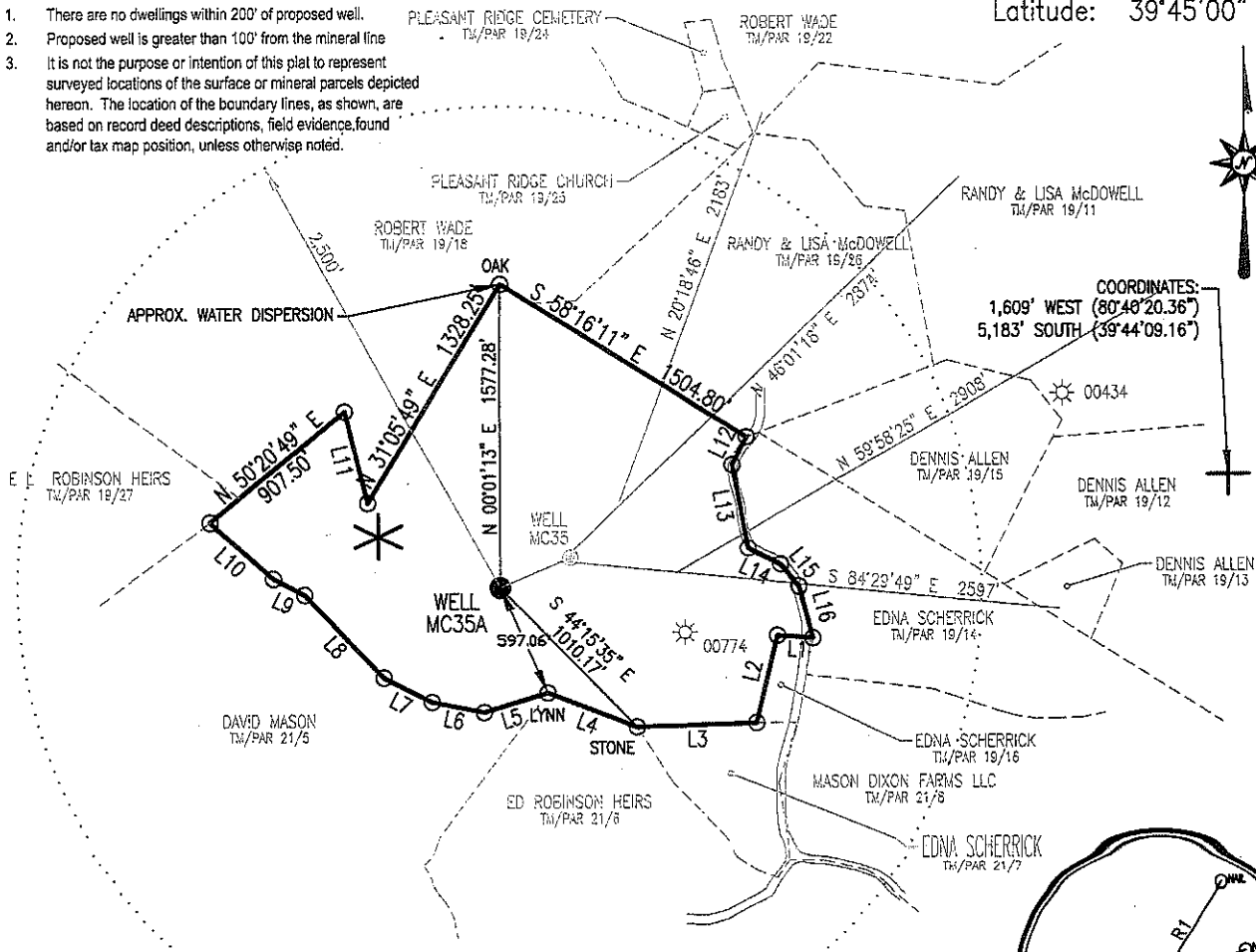


NOTES:

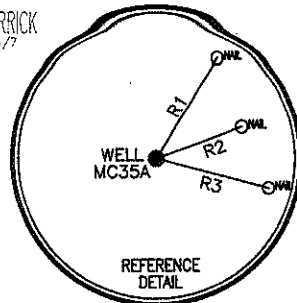
