Drill through the Marcellus and TD Pilot Hole 100' into the Onondaga. Log vertical section and run a solid cement plug back to proposed KOP. Drill curve and lateral per proposed well plan, run and cement production casing. Perform CBL from 60 deg to surface, make cleanout run, and stimulate.

20) Describe fracturing/stimulating methods in detail, including anticipated max pressure and max rate:

Well to be completed with approximately 26,052,000 lb prop and approximately 402,365 bbl of water. Max rate = 80 bpm; max psi = 9,000#.

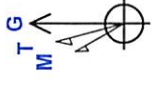

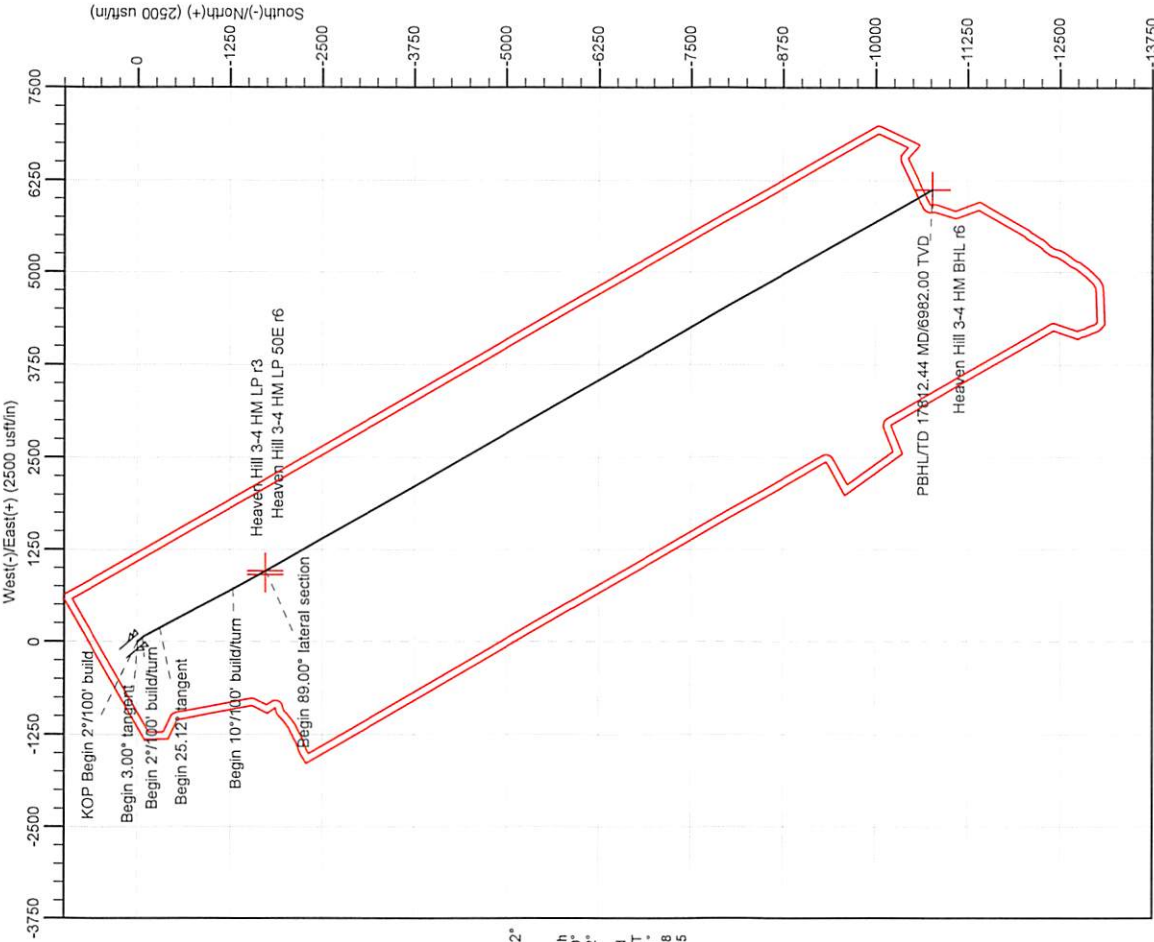
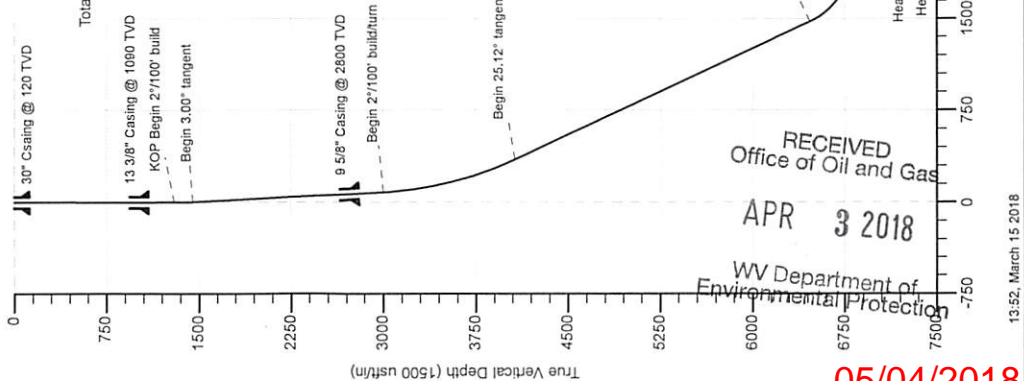

ASSIGNMENT AND CONVEYANCE

THIS ASSIGNMENT AND CONVEYANCE (the "Assignment") is made and entered into this 17th day of May, 2016 (the "Effective Date"), by and between **CHEVRON U.S.A. INC.** (hereinafter "Assignor") and **TH EXPLORATION, LLC** (hereinafter "Assignee") pursuant to the terms of that certain Acreage Trade Agreement between the Assignor and the Assignee dated May 2, 2016 (the "Acreage Trade Agreement"). Capitalized terms used but not defined herein and defined in the Acreage Trade Agreement shall have the meanings given to such terms in the Acreage Trade Agreement.

WITNESSETH:

WHEREAS, Assignor desires to assign, set over, and transfer to Assignee all of Assignor's right, title, and interest in and to those certain Oil and Gas Leases situated in Marshall County, West Virginia, as described in Exhibit "A", and as depicted in Exhibits "A-1" and "A-2", attached hereto and made a part hereof (hereinafter the "Leases"); and

WHEREAS, Assignor desires to assign, set over, and transfer to Assignee all of Assignor's right, title, and interest in and to the Leases as described below.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the limited warranties, restrictions and conditions hereinafter mentioned, the parties hereto, intending to be legally bound, do covenant and agree as follows:

1. Assignment. TO HAVE AND TO HOLD such right, title and interest in and to the Leases unto Assignee or its designee, and their respective successors and assigns, forever, in accordance with the provisions of this Assignment.

2. Special Warranty. 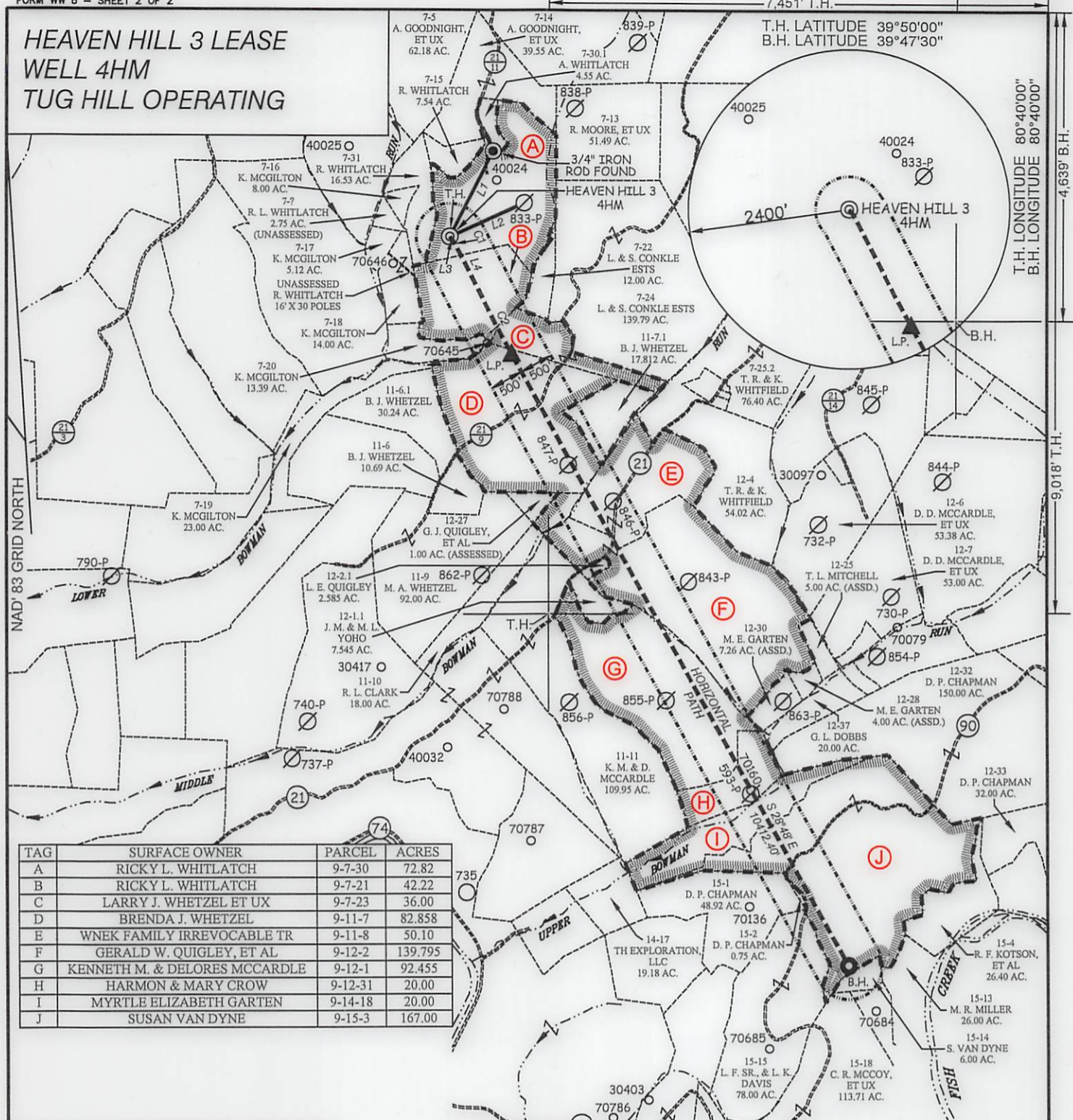

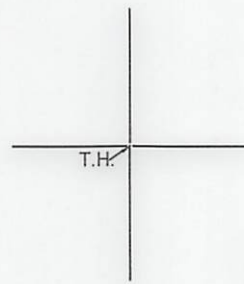

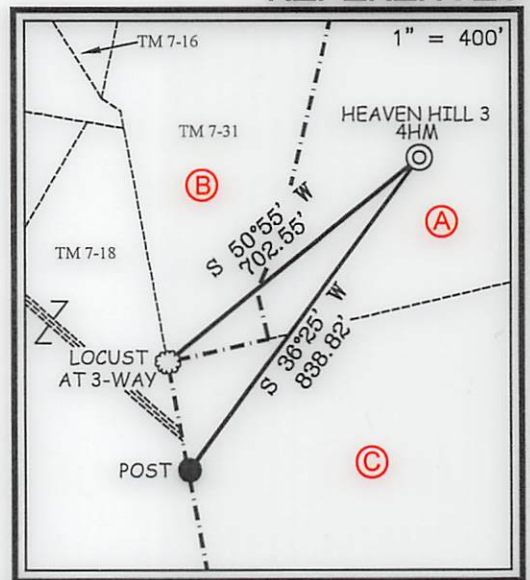
