## 11. Proposed Well Work:

Well A-1955 will be drilled to approximately 710' KB. The 8-5/8" casing will be set at approximately 690' KB and then cemented to surface. The well will then be drilled to 1,967' KB and the 4-1/2" casing set at approximately 1967' KB. The 4-1/2" casing will be cemented to 1000' KB. The well will then be hydraulically fractured in the Fourth Sand Formation.
