MERP Plugging Work Order for 4707900243 Switzer #8

1. Notify OOG Inspector. Notification is required 24 hours prior to commencing the plugging.
2. TIH to check TD 2344'. Pull all tubing at 2199' and any packer set. Unable to pull then contact inspector on how to proceed.
3. There is no mention of any cement on any casing strings in this well. Contact inspector for need to run bond log(s) to determine cement and top(s). All casing in this well that is not bonded by cement and cannot be retrieved must be perforated at point approved by the inspector.
4. TIH with tubing to TD at 2344". Pump gel followed by bottom hole cement plug 2277'-2177' (Berea top 2297'). TOH and WOC.
5. Try pulling 1895' of 6 5/8" casing. Try freepoint, cut and pull. If casing shoe/packer to be left in place put cement plug 10' below it and 90' above it (100' plug). Contact inspector per item 3 above for points of interest to perforate casing.
6. TIH, tag plug and pump gel followed by cement plug 1788-1688'(Big Injun top at 1808')
7. Pump gel followed by cement plug 990'-880' (Salt sand top 1110' and acts as elevation plug).
8. Pump gel followed by cement plug 100' to surface.
9. Erect monument with API number affixed.
10. NOTE.....Any casing found in the well without cement in the annulus that cannot be retrieved must be perforated and cemented at all saltwater, freshwater, coal, oil, gas and largest casing shoe. CLASS A cement.

If you have been contacted by the well operator and you have signed a "voluntary statement of no objection" to the planned work described in these materials, then the permit may be issued at any time.

Comments must be in writing. Your comments must include your name, address and telephone number, the well operator's name and well number and the approximate location of the proposed well site including district and county from the application. You may add other documents, such as sketches, maps or photographs to support your comments.

The Chief has the power to deny or condition a well work permit based on comments on the following grounds:

- 1) The proposed well work will constitute a hazard to the safety of persons.
- 2) The soil erosion and sediment control plan is not adequate or effective;
- 3) Damage would occur to publicly owned lands or resources;
- 4) The proposed well work fails to protect fresh water sources or supplies;
- 5) The applicant has committed a substantial violation of a previous permit or a substantial violation of one or more of the rules promulgated under Chapter 22, and has failed to abate or seek review of the violation...".

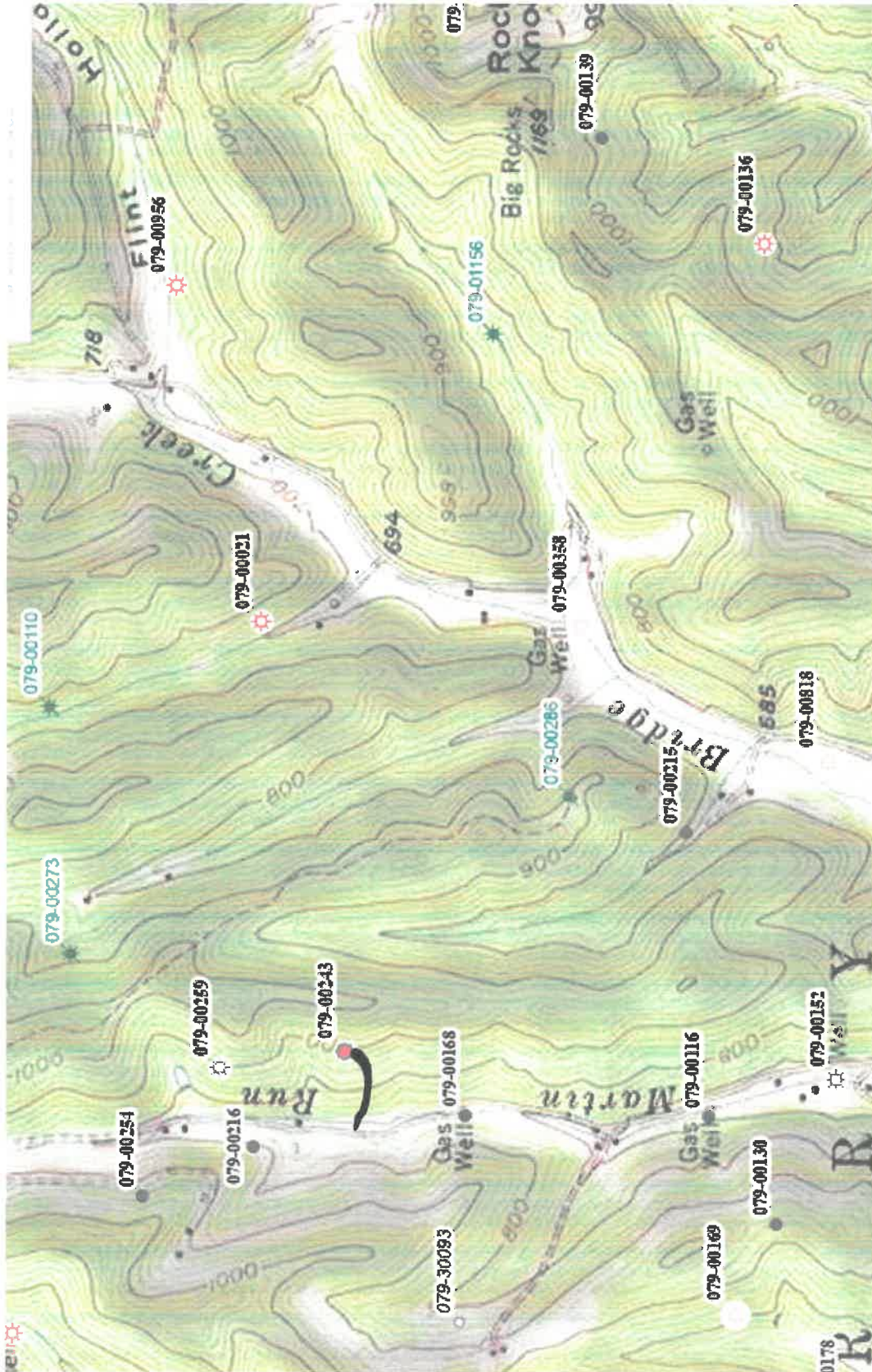
