- 1. Notify Inspector Joe Taylor @ 304-380-7469, 48 hrs prior to commencing operations.
- 2. MIRU service rig and ancillary equipment. Rig up to drill/mill out and take returns.
- 3. Cement was drilled out of 7" to 1034'. Getting back metal shavings and wearing bits out. It's believed that the original hole was crooked or at least has some type of dogleg in it.
- 4. Attempt to cut 7" csg as close to 1,034' as possible. TOOH w/ 7" csg, laying down.
- 5. TIH w/ tbg to 1034'. Pump 6% bentonite gel. Pump at least 50 bbls gel. Pump 534' Class L cement plug from **1034' to 500'.** Approximately 223 sks @ 1.14 yield. WOC. Tag TOC. Top of as needed. Do not omit any plugs listed below. Perforate as needed.
- 6. TIH w/ tbg to 500'. Pump 500' Class L cement plug from **500' to Surface (Surface Plug).** Approximately 211 sks @ 1.14 yield. Top off as needed. Perforate as needed.
- 7. Reclaim well site and erect plugging monument to WV DEP specifications.
