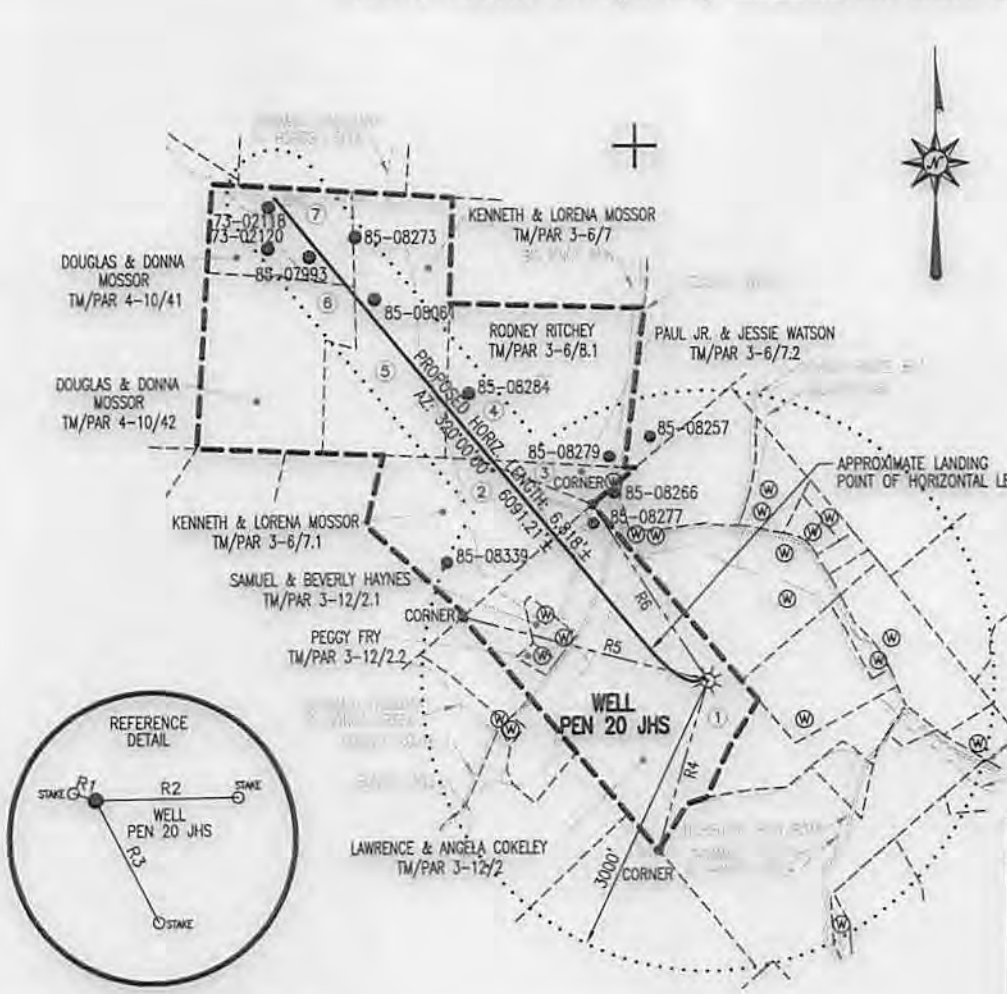


Well is located on topo map 1,899 feet south of Latitude: 39° 20' 00"

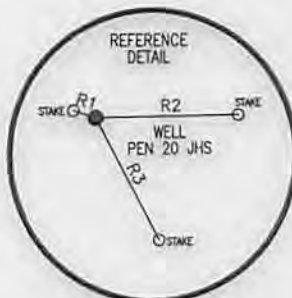

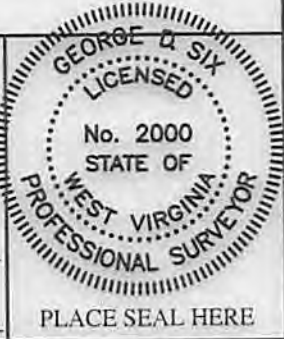

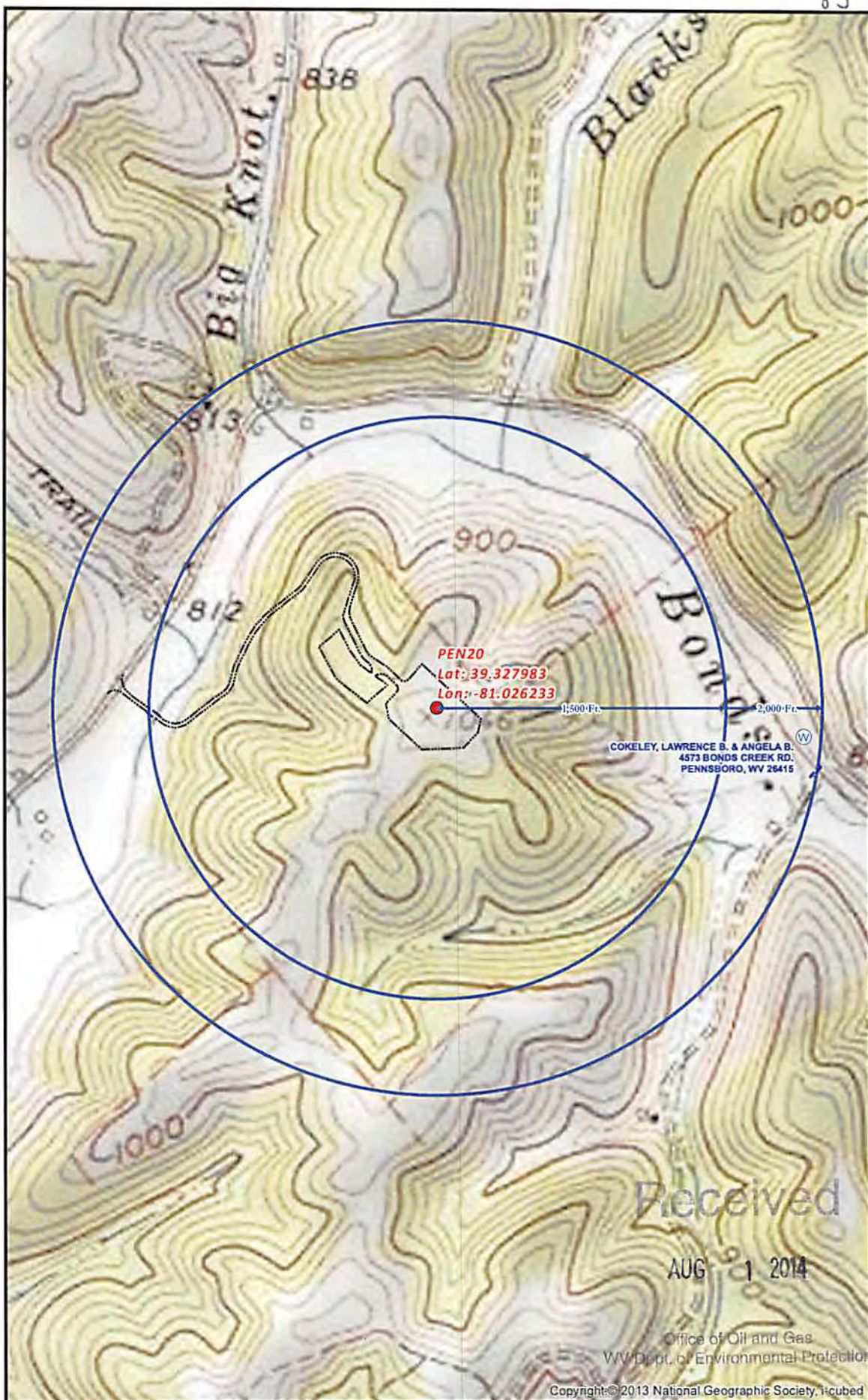
