This well work permit is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to any additional specific conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Please be advised that form WR-35, Well Operators Report of Well Work is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

PERMIT CONDITIONS

West Virginia Code § 22-6A-8(d) allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

CONDITIONS

- 1. This proposed activity may require permit coverage from the United States Army Corps of Engineers (USACE). Through this permit, you are hereby being advised to consult with USACE regarding this proposed activity.
- 2. If the operator encounters an unanticipated void, or an anticipated void at an unanticipated depth, the operator shall notify the inspector within 24 hours. Modifications to the casing program may be necessary to comply with W. Va. Code § 22-6A-5a (12), which requires drilling to a minimum depth of thirty feet below the bottom of the void, and installing a minimum of twenty (20) feet of casing. Under no circumstance should the operator drill more than one hundred (100) feet below the bottom of the void or install less than twenty (20) feet of casing below the bottom of the void.
- 3. When compacting fills, each lift before compaction shall not be more than 12 inches in height, and the moisture content of the fill material shall be within limits as determined by the Standard Proctor Density test of the actual soils used in specific engineered fill, ASTM D698, Standard Test Method for Laboratory Compaction Characteristics of Soil Using Standard Effort, to achieve 95 % compaction of the optimum density. Each lift shall be tested for compaction, with a minimum of two tests per lift per acre of fill. All test results shall be maintained on site and available for review.
- 4. Operator shall install signage per § 22-6A-8g (6) (B) at all source water locations included in their approved water management plan within 24 hours of water management plan activation.
- 5. Oil and gas water supply wells will be registered with the Office of Oil and Gas and all such wells will be constructed and plugged in accordance with the standards of the Bureau for Public Health set forth in its Legislative rule entitled *Water Well Regulations*, 64 C.S.R. 19. Operator is to contact the Bureau of Public Health regarding permit requirements. In lieu of plugging, the operator may transfer the well to the surface owner upon agreement of the parties. All drinking water wells within fifteen hundred feet of the water supply well shall be flow tested by the operator upon request of the drinking well owner prior to operating the water supply well.
- 6. Pursuant to the requirements pertaining to the sampling of domestic water supply wells/springs the operator shall, no later than thirty (30) days after receipt of analytical data provide a written copy to the Chief and any of the users who may have requested such analyses.
- 7. 24 hours prior to the initiation of the completion process the operator shall notify the Chief or his designee.
- 8. During the completion process the operator shall monitor annular pressures and report any anomaly noticed to the chief or his designee immediately.
- 9. If any explosion or other accident causing loss of life or serious personal injury occurs in or about a well or well work on a well, the well operator or its contractor shall give notice, stating the particulars of the explosion or accident, to the oil and gas inspector and the Chief, within 24 hours of said accident.
- 10. During the casing and cementing process, in the event cement does not return to the surface, the oil and gas inspector shall be notified within 24 hours.
- 11. The operator shall provide to the Office of Oil and Gas the dates of each of the following within 30 days of their occurrence: completion of construction of the well pad, commencement of drilling, cessation of drilling, completion of any other permitted well work, and completion of the well. Such notice shall be provided by sending an email to DEPOOGNotify@wv.gov.

ORDER ISSUED UNDER WEST VIRGINIA CODE, CHAPTER 22, ARTICLE 6A

INTRODUCTION

This Order (hereinafter "Order") is issued by the Office of Oil and Gas (hereinafter "OOG"), by and through its Chief, pursuant to the authority of W. Va. Code §§ 22-1-1, 22-6-1 and 22-6A-1 et seq. to Tribune Resources, LLC (hereinafter "Tribune" or "Operator"), collectively the "Parties."

FINDINGS OF THE CHIEF

In support of this Order, the Chief hereby finds the following:

- OOG, an office within the West Virginia Department of Environmental Protection, is the agency
 with the duty and authority to execute and enforce W. Va. Code §22-6-1 and §22-6A-1 et seq., and
 the rules and regulations promulgated thereunder.
- Tribune is a "person" as defined by W. Va. Code §22-6-1(n), with a corporate address as 3861 Ambassador Caffery Park, Lafayette, LA 70503.
- On October 17, 2022, Tribune submitted well work permit applications identified as API# 47-095-02831, 47-095-02832, 47-095-02833, 47-095-02834, 47-095-02835, 47-095-02836, 47-095-02837 and 47-095-02838. The well is located on the BFT Pad in the McElroy District of Tyler County, West Virginia.
- 4. On October 17, 2022. Tribune requested a waiver for Wetlands 1 and 2, along with perennial streams Unnamed Tributary to Left Hand Fork and Left Hand Fork as outlined in Attachment 1, from well location restriction requirements in W. Va, Code §22-6A-12(b) for the well work permit applications identified as API# 47-095-02831, 47-095-02832, 47-095-02833, 47-095-02834, 47-095-02835, 47-095-02836, 47-095-02837 and 47-095-02838.

CONCLUSIONS OF LAW

- 1. West Virginia Code §22-1-6(d) requires, in part, that "in addition to other powers, duties and responsibilities granted and assigned to the secretary by this chapter, the secretary is authorized and empowered to...(3) Enter private lands to make surveys and inspections for environmental protection purposes; to investigate for violations of statutes or rules which the Office of Oil and Gas is charged with enforcing; to serve and execute warrants and processes; to make arrests; issue orders, which for the purposes of this chapter include consent agreements; and to otherwise enforce the statutes or rules which the Office of Oil and Gas is charged with enforcing."
- 2. West Virginia Code §22-6A-2(a)(6) requires, in part, that "Concomitant with the broad powers to condition the issuance of well work permits, the secretary should also have broad authority to waive certain minimum requirements of this article when, in his or her discretion, such waiver is appropriate: *Provided*, That the secretary shall submit a written report of the number of waivers granted to the Legislature commencing January 1, 2013, and each year thereafter."
- 3. West Virginia Code §22-6A-12(b) requires, in part, that "no well pad may be prepared or well drilled within one hundred feet measured horizontally from any perennial stream, natural or artificial lake, pond or reservoir, or a wetland, or within three hundred feet of a naturally reproducing trout stream. No well pad may be located within one thousand feet of a surface or ground water intake of a public water supply. The distance from the public water supply as identified by the Office of Oil and Gas shall be measured as follows: (1) For a surface water intake on a lake or reservoir, the distance shall be measured from the boundary of the lake or reservoir. (2) For a surface water intake on a flowing stream, the distance shall be measured from a semicircular radius extending upstream of the surface water intake. (3) For a groundwater source, the distance shall be measured from the wellhead or spring. The Office of Oil and Gas may, in its discretion, waive these distance restrictions upon submission of a plan identifying sufficient measures, facilities or practices to be employed during well site construction, drilling and operations to protect the waters of the state. A waiver, if granted, shall impose any permit conditions as the secretary considers necessary."

<u>ORDER</u>

West Virginia Code §22-6A-12(b) requires, in part, that "no well pad may be prepared or well drilled within one hundred feet measured horizontally from any perennial stream, natural or artificial lake, pond or reservoir, or a wetland. The Office of Oil and Gas grants the request for a waiver for Wetlands 1 and 2, along with perennial streams Unnamed Tributary to Left Hand Fork and Left Hand Fork from well location restriction requirements in W. Va. Code §22-6A-12(b) for the well work permit applications identified as API# 47-095-02831, 47-095-02832, 47-095-02833, 47-095-02834, 47-095-02835, 47-095-02836, 47-095-02837 and 47-095-02838. The Office of Oil and Gas hereby **ORDERS** that Tribune shall meet the following site construction and operational requirements for the BFT Well Pad:

- a. A berm shall be constructed around the perimeter of the pad to contain any potential spills and storm water runoff. Berm is to be at least twenty-four inches (24") in height;
- b. Erosion control blankets shall be installed on all slopes and down gradient locations of the pad as erosion and sediment controlling BMPs;
- c. Wetlands 1 and 2, along with perennial streams Unnamed Tributary to Left Hand Fork and Left Hand Fork shall be protected by thirty two inch (32") compost filter sock and super silt fence. This along with temporary and permanent vegetative cover will prevent sediment from reaching the wetlands;
- d. Disturbed areas not used for operations shall be seeded and mulched per the seeding tables in the WVDEP-OOG Erosion and Sediment Control Manual;
- e. Drill cuttings and associated drilling mud shall be disposed of in a permitted landfill;
- f. Waste generated by the flowback treatment systems shall be sent to offsite disposal at a permitted landfill;
- g. Weekly site inspections shall be conducted to monitor and maintain the integrity of the BMP storm water controls;
- h. Weekly storm water and spill prevention inspections shall be conducted focusing on storm water and spill prevention BMPs and maintenance of these BMPs;
- i. Inspections of the storm water and spill prevention measures shall be conducted after any major storm event defined as a half inch (1/2") rain within any twenty-four (24) hour period;
- j. Pad inspections shall be conducted no less than once a week to identify and mitigate potential deficiencies;
- k. All records from inspections shall be maintained on site for the life of the project and be available upon request.

Answer the questions below to request a waiver from West Virginia Department of Environmental Protection for any wetlands or perennial streams which lie within one hundred feet of proposed project Limit of Disturbance (LOD), which includes any erosion and sediment control devices to be used.

This waiver shall be requested pursuant to Chapter 22 Article 6A Section 12 of West Virginia Code, which states:

§22-6A-12(b) No well pad may be prepared or well drilled within one hundred feet measured horizontally from any perennial stream, natural or artificial lake, pond or reservoir, or a wetland, or within three hundred feet of a naturally reproducing trout stream. No well pad may be located within one thousand feet of a surface or ground water intake of a public water supply. The distance from the public water supply as identified by the department shall be measured as follows:

(1) For a surface water intake on a lake or reservoir, the distance shall be measured from the boundary of the lake or reservoir.

(2) For a surface water intake on a flowing stream, the distance shall be measured from a semicircular radius extending upstream of the surface water intake.

(3) For a groundwater source, the distance shall be measured from the wellhead or spring.

The department may, in its discretion, waive these distance restrictions upon submission of a plan identifying sufficient measures, facilities or practices to be employed during well site construction, drilling and operations to protect the waters of the state. A waiver, if granted, shall impose any permit conditions as the secretary considers necessary.

§22-6A-12(c) Notwithstanding the foregoing provisions of this section, nothing contained in this section prevents an operator from conducting the activities permitted or authorized by a Clean Water Act Section 404 permit or other approval from the United States Army Corps of Engineers within any waters of the state or within the restricted areas referenced in this section.

1. Describe the proposed project location, including unique identifying names of all wetlands, and the names of perennial streams for which the waiver is sought.

This project is located in McElroy District, Tyler County off of Left Hand Fork Road. There are two wetlands and two Perennial streams identified in the vicinity of the project which require a waiver.

Wetland #1: Located immediately north of the well pad across Left Hand Fork Road. Wetland #2: Located immediately southwest of the well pad.

Unnamed Tributary to Left Hand Fork: Located immediately West of the well pad. Left Hand Fork: Located immediately South of the well pad.

NOTE: Wetland #3 is impacted during construction. A Nationwide Permit 39 is being obtained from the ACOE.

2. Justify the proposed activity by describing alternatives to this project that were considered.

- a. Include a No-Action Alternative as to show "the future without the project"
- b. Location Alternatives must be shown
- c. Must demonstrate why a one hundred foot buffer cannot be maintained
- d. Describe how the proposed project is the least environmentally damaging practicable alternative

a. A no-action alternative would result in the in-ability to extract any gas from this unit. The only available area for pad construction would be in the proposed location as shown in the attached drawing. Within this unit boundary there are no other viable pad locations, steepness of slopes, impacts to waters of the U.S., additional wetland impacts, and/or violating dwelling setbacks. In short, the land surface and gas below would be unable to be developed in the Unit Boundary shown.

b. Refer to Exhibit "B" for the following elimination of alternatives that would move the well pad greater than 100 feet away from the wetlands in question while keeping the same project location.

West: Moving the pad west would result in impacts to wetland #2. These impacts would end up being permanent. Also, would require a wetland waiver to wetland #1. In addition, the impact to wetland #3 would not be eliminated. This would also result in the center of wells being less than 625' from a dwelling.

South: Moving the pad south would result to an impact to the perennial stream (Left Hand Fork) due to the steep terrain. East: Moving the pad east would result to an impact to the perennial stream (Left Hand Fork) due to the steep terrain and limited space available. This would potentially move

the well pad outside the unit boundary. North: Moving the pad north would result to impacts to wetland #1 and the perennial stream (Unnamed Tributary to Left Hand Fork). These impacts would end up being permanent. Also, would require a wetland waiver to wetland #2 & #3.

permanent. Also, would require a webland waiver to webland #2 & #5. Refer to Exhibit "A" for the following elimination of alternatives that would move the well pad in a completely new location away form its current proposed location.

East: The site is unable to move east because it would result in the well pad being outside the unit boundary.

North: The site is unable to move north as the slopes are too steep and there would be direct stream impacts.

West: The site is unable to move west as the center of wells will be within 625' of dwellings. Also, any area that isn't too steep would cause direct impacts to streams. South: The site is unable to move south as the slopes are too steep. Also, any area that isn't too steep would cause direct impacts to streams and the center of wells will be within 625' of dwellings.

c. A 100' buffer cannot be maintained because of the three wetlands delineated around the project location. An existing AST pad is being utilized to reduce earth disturbance as much as possible. The well pad cannot be any smaller due to the fact the drill rig would not fit.

d. This proposed project is the least environmentally damaging practicable alternative as it minimizes aquatic resource impacts. The proposed well pad is on an existing AST pad which will allow the least amount of earth disturbance during construction. Any other viable alternative would result in more earth disturbance and additional direct impacts/ elimination of aquatic resources.

3. Identify sufficient measures, facilities or practices to be employed during well site construction, drilling and operations to protect the waters of the state. This description should include all additional erosion and sediment control measures and devices that will be used.

There are two wetlands & two perennial streams located within 100 foot of the well pad's limit of disturbance.

Wetland #1 covers an area of 10,138 SF (0.232 acres) and is located north of the proposed well pad across Left Hand Fork Road. Prior to construction the limit of disturbance will be lined with orange safety fence near wetland #1 to ensure contractors are aware of its location. In addition, super silt fence and 32" compost filter sock will be utilized as the primary erosion and sediment control BMP near wetland #1.

Wetland #2 covers an area of 4,882 SF (0.110 acres) and is located west of the proposed well pad. There will be no additional work in this area of the proposed well pad because the existing AST pad and containment berm is being utilized in this location.

Perennial Stream (Left Hand Fork) is located south of the proposed well pad location. Where new construction is needed super silt fence and 32" compost filter sock lined the fill slope as the primary erosion and sediment control BMP.

Perennial Stream (Unnamed Tributary Left Hand Fork) is located west of the proposed well pad location. There will be no additional work in this area of the proposed well pad because the existing AST pad and containment berm is being utilized in this location.

4. Provide mapping, plans, specifications and design analysis for the preferred alternative to the project.

a. Specify in writing what additional controls, measures, devices, monitoring, etc. will be used to protect these wetlands and/or perennial streams for which the waiver is sought.

An Erosion and Sediment Control and Site Plan has been provided. In addition, blow ups of the areas in guestion are also provided in this waiver.


The proposed well pad will utilize the existing containment berm from the existing AST pad and expand the containment berm where additional area for the well pad is proposed. This berm is 2.8' in height and has a base of 15.0'. A detail of this berm is provided on the Erosion and Sediment Control Plan. This provides more than adequate containment during and after drilling activities.


Wetland #1 is 35' from the proposed limit of disturbance. It is north across Left Hand Fork Road and 35' from the well pad top of slope.


Wetland #2 is 70' from the proposed limit of disturbance. It is below an established fill slope that will not be disturbed.

Perennial Stream (Left Hand Fork) is 17' from the proposed limit of disturbance and 33' from the well pad toe of slope.

Perennial Stream (Unnamed Tributary Left Hand Fork) is 5' from the proposed limit of disturbance. It is below an established fill slope that will not be disturbed.

19) Describe proposed well work, including the drilling and plugging back of any pilot hole:

The well will be spud using a conductor rig. It will drill down 100' per the casing program. It will set 20" casing and circulate cement back to surface. The conductor rig will move off location, a rig capable of drilling to TD will be moved in to complete the well. We will drill to 650' on fluid and set a 13-3/8" fresh water casing string. Drilling will continue to 3,000' where 9-5/8" casing will be set. Note: If we should encounter a void during drilling, a cement basket will be placed above and below void area-balance cement to bottom of void and grout from basket to surface or run external casing packer/cementing stage tool above void interval and perform 2 stage cementing operation dependent upon depth of void. (*If freshwater is encountered deeper than anticipated, it must be protected, set casing 50' below and cement to surface). We will continue drilling the well to total depth and run/cement casing as per the attached program.

20) Describe fracturing/stimulating methods in detail, including anticipated max pressure and max rate:

Multi-stage slickwater fracturing with frac sand. Wireline conveyed pump down frac plug and perforating to isolate frac stages. Maximum pressure will be 10,000 psig. and maximum rate will be 95 bpm.

21) Total Area to be disturbed, including roads, stockpile area, pits, etc., (acres): 4_____

22) Area to be disturbed for well pad only, less access road (acres): 3.54

23) Describe centralizer placement for each casing string:


Pursuant to W. Va. Code R. § 35-8-5.7.a, the operator shall provide the Well Site Safety Plan to the surface owner and any water purveyor or surface owner subject to notice and water testing as provided in section 15 of this rule.

Pursuant to W. Va. Code R. § 35-8-15.2.c, this notice shall: (1) contain a statement of the surface owner's and water purveyor's right to request sampling and analysis; (2) advise the surface owner and water purveyor of the rebuttable presumption for contamination or deprivation of a fresh water source or supply; advise the surface owner and water purveyor that refusal to allow the operator to conduct a pre-drilling water well test constitutes a method to rebut the presumption of liability; (3) advise the surface owner and water purveyor of his or her independent right to sample and analyze any water supply at his or her own expense; advise the surface owner and water purveyor whether or not the operator will utilize an independent laboratory to analyze any sample; and (4) advise the surface owner and or water purveyor that he or she can obtain from the Chief a list of water testing laboratories in the subject area capable of and qualified to test water supplies in accordance with standard acceptable methods.

Additional information related to horizontal drilling may be obtained from the Secretary, at the WV Department of Environmental Protection headquarters, located at 601 57th Street, SE, Charleston, WV 25304 (304-926-0450) or by visiting <u>www.dep.wv.gov/oil-and-gas/pages/default.aspx</u>.

Well Location Restrictions

Pursuant to W. Va. Code § 22-6A-12, Wells may not be drilled within two hundred fifty feet measured horizontally from any existing water well or developed spring used for human or domestic animal consumption. The center of well pads may not be located within six hundred twenty-five feet of an occupied dwelling structure, or a building two thousand five hundred square feet or larger used to house or shelter dairy cattle or poultry husbandry. This limitation is applicable to those wells, developed springs, dwellings or agricultural buildings that existed on the date a notice to the surface owner of planned entry for surveying or staking as provided in section ten of this article or a notice of intent to drill a horizontal well as provided in subsection (b), section sixteen of this article was provided, whichever occurs first, and to any dwelling under construction prior to that date. This limitation may be waived by written consent of the surface owner transmitted to the department and recorded in the real property records maintained by the clerk of the county commission for the county in which such property is located. Furthermore, the well operator may be granted a variance by the secretary from these distance restrictions upon submission of a plan which identifies the sufficient measures, facilities or practices to be employed during well site construction, drilling and operations. The variance, if granted, shall include terms and conditions the department requires to ensure the safety and protection of affected persons and property. The terms and conditions may include insurance, bonding and indemnification, as well as technical requirements. (b) No well pad may be prepared or well drilled within one hundred feet measured horizontally from any perennial stream, natural or artificial lake, pond or reservoir, or a wetland, or within three hundred feet of a naturally reproducing trout stream. No well pad may be located within one thousand feet of a surface or ground water intake of a public water supply. The distance from the public water supply as identified by the department be measured as follows: (1) For a surface water intake on a lake or reservoir, the distance shall be measured from the bourdary of and lake or reservoir. (2) For a surface water intake on a flowing stream, the distance shall be measured from a semicircular radius extending upstream of the surface water intake. (3) For a groundwater source, the distance shall be measured from the wellhead or spring. The department may, in its discretion, waive these distance restrictions upon submission of a plan identifying sufficient measures facilities or practices to be employed during well site construction, drilling and operations to protect the waters of the state. A wainten the state in the state is all impose any permit conditions as the secretary considers necessary. (c) Notwithstanding the foregoing provisions of this section, nothing contained in this section prevents an operator from conducting the activities permitted or authorized by a Clean Water Act Section 404 permit or other approval from the United States Army Corps of Engineers within any waters of the state or within the restricted areas referenced in this section. (d) The well location restrictions set forth in this section shall not apply to any well on a multiple well pad if at least one of the wells was permitted prior to the effective date of this article. (e) The secretary shall, by December 31, 2012, report to the Legislature on the noise, light, dust and volatile organic compounds generated by the drilling of horizontal wells as they relate to the well location restrictions regarding occupied dwelling structures pursuant to this section. Upon a finding, if any, by the secretary that the well location restrictions regarding occupied dwelling structures are inadequate or otherwise require alteration to address the items



examined in the study required by this subsection, the secretary shall have the authority to propose for promulgation legislative rules establishing guidelines and procedures regarding reasonable levels of noise, light, dust and volatile organic compounds relating to drilling horizontal wells, including reasonable means of mitigating such factors, if necessary.

Water Well Testing:

Pursuant to West Virginia Code § 22-6A-10(d), notification shall be made, with respect to surface landowners identified in subsection (b) or water purveyors identified in subdivision (5), subsection (b) of this section, of the opportunity for testing their water well. The operator shall provide an analysis to such surface landowner or water purveyor at their request.

Water Testing Laboratories:

Pursuant to West Virginia Code § 22-6A-10(i), persons entitled to notice pursuant to subsection (b) of this section may contact the department to ascertain the names and locations of water testing laboratories in the subject area capable and qualified to test water supplies in accordance with standard accepted methods. In compiling that list of names the department shall consult with the state Bureau for Public Health and local health departments. A surface owner and water purveyor has an independent right to sample and analyze any water supply at his or her own expense. The laboratory utilized by the operator shall be approved by the agency as being certified and capable of performing sample analyses in accordance with this section.

Rebuttable Presumption for Contamination or Deprivation of a Fresh Water Source or Supply:

W. Va. Code § 22-6A-18 requires that (b) unless rebutted by one of the defenses established in subsection (c) of this section, in any action for contamination or deprivation of a fresh water source or supply within one thousand five hundred feet of the center of the well pad for horizontal well, there is a rebuttable presumption that the drilling and the oil or gas well or either was the proximate cause of the contamination or deprivation of the fresh water source or supply. (c) In order to rebut the presumption of liability established in subsection (b) of this section, the operator must prove by a preponderance of the evidence one of the following defenses: (1) The pollution existed prior to the drilling or alteration activity as determined by a predrilling or prealteration water well test. (2) The landowner or water purveyor refused to allow the operator access to the property to conduct a predrilling or prealteration water well test. (3) The water supply is not within one thousand five hundred feet of the well. (4) The pollution occurred more than six months after completion of drilling or alteration activities. (5) The pollution occurred as the result of some cause other than the drilling or alteration activity. (d) Any operator electing to preserve its defenses under subdivision (1), subsection (c) of this section shall retain the services of an independent certified laboratory to conduct the predrilling or prealteration water well test. A copy of the results of the test shall be submitted to the department and the surface owner or water purveyor in a manner prescribed by the secretary. (e) Any operator shall replace the water supply of an owner of interest in real property who obtains all or part of that owner's supply of water for domestic, agricultural, industrial or other legitimate use from an underground or surface source with a comparable water supply where the secretary determines that the water supply has been affected by contamination, diminution or interruption proximately caused by the oil or gas operation, unless waived in writing by that owner. (f) The secretary may order the operator conducting the oil or gas operation to: (1) Provide an emergency drinking water supply within twenty-four hours; (2) Provide temporary water supply within seventy-two hours; (3) Within thirty days begin activities to establish a permanent water supply or submit a proposal to the secretary outlining the measures and timetables to be used in establishing a permanent supply. The total time in providing a permanent water supply may not exceed two years. If the operator demonstrates that providing a permanent replacement water supply cannot be completed within two years, the secretary may extend the time frame on case-by-case basis; and (4) Pay all reasonable costs incurred by the real property owner in securing a water supply. (g) A person as described in subsection (b) of this section aggrieved under the provisions of subsections (b), (e) or (f) of this section may seek relief in court... (i) Notwithstanding the denial of the operator of responsibility for the damage to the real property owner's water supply or the status of any appeal on determination of liability for the damage to the real property owner's water supply, the operator may not discontinue providing the required water service until authorized to do so by the secretary or a court of competent jurisdiction.

The Chief has the power to deny or condition a well work permit. Pursuant to West Virginia Code § 22-6A-8(d), the permit may not be issued or be conditioned, including conditions with respect to the location of the well and access roads prior to issuance if the director determines that:

- (1) The proposed well work will constitute a hazard to the safety of persons;
- (2) The plan for soil erosion and sediment control is not adequate or effective;
- (3) Damage would occur to publicly owned lands or resources; or
- (4) The proposed well work fails to protect fresh water sources or supplies.

A permit may also be denied under West Virginia Code § 22-6A-7(k), the secretary shall deny the issuance of a permit if the secretary determines that the applicant has committed a substantial violation of a previously issued permit for a horizontal well, including the applicable erosion and sediment control plan associated with the previously issued permit, or a substantial violation of one or more of the rules promulgated under this article, and in each instance has failed to abate or seek review of the violation within the time prescribed by the secretary pursuant to the provisions of subdivisions (1) and (2), subsection (a), section five of this article and the rules promulgated hereunder, which time may not be unreasonable.

Pursuant to West Virginia Code § 22-6A-10(g), any person entitled to submit written comments to the secretary pursuant to subsection (a), section eleven of this article, shall also be entitled to receive from the secretary a copy of the permit as issued or a copy of the order modifying or denying the permit if the person requests receipt of them as a part of the written comments submitted concerning the permit application. Such persons may request, at the time of submitting written comments, notice of the permit decision and a list of persons qualified to test water.


