PERMIT CONDITIONS

2. (H) DENOTES LOCATION OF WELL ON UNITED STATES TOPOGRAPHIC MAPS

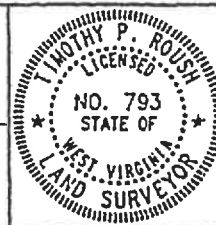

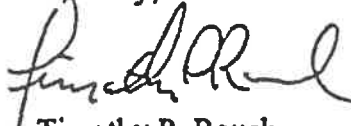

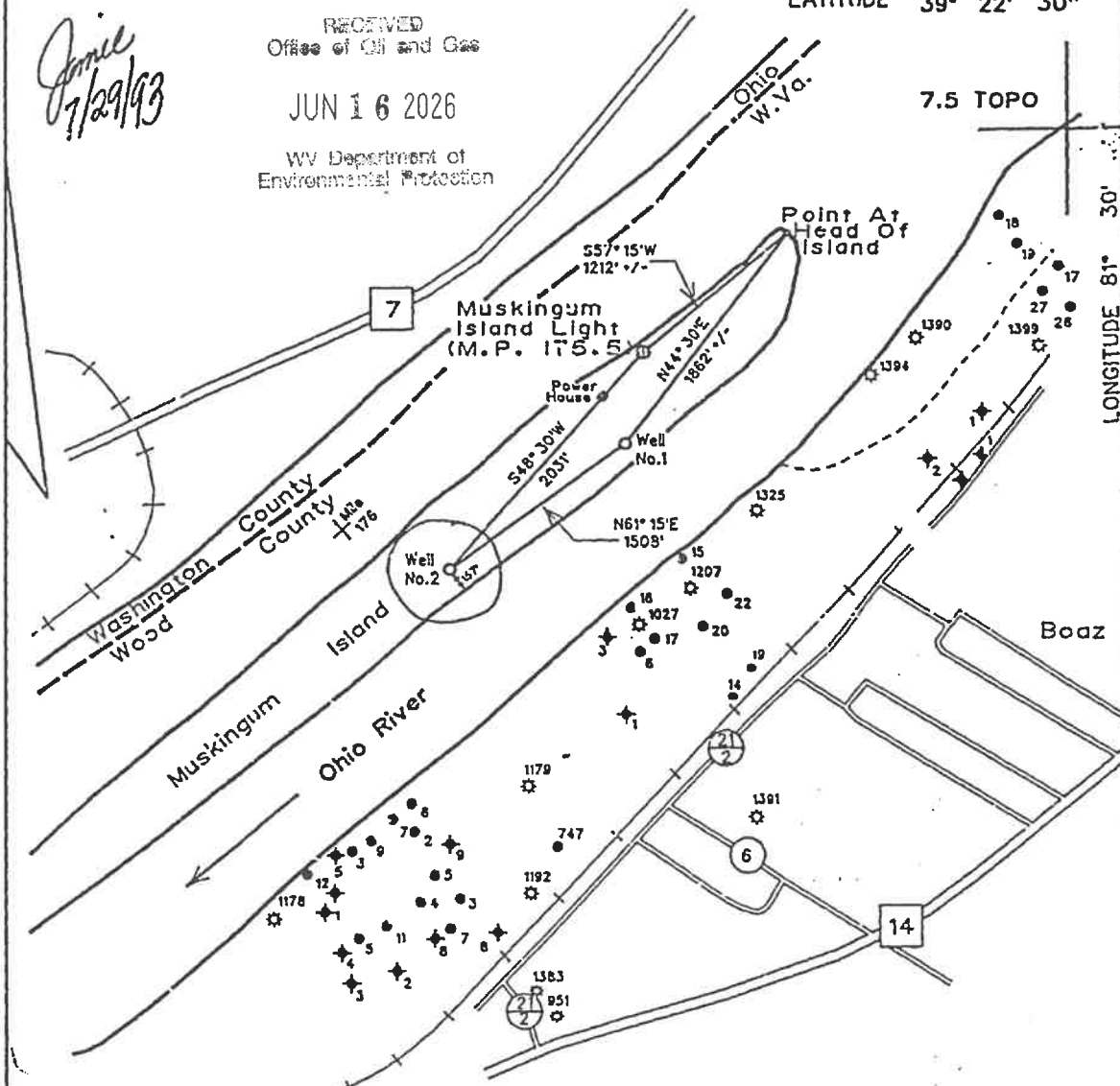

WH DENOTES LOCATION OF WELL ON UNITED STATES TOPOGRAPHIC MAPS

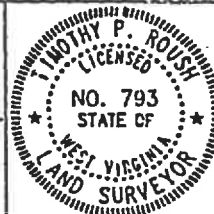

I refer to the pre-construction notification (PCN) requesting a Department of the Army (DA) authorization for the discharge of dredged and/or fill material into waters of the United States (U.S.) in association with the construction of the Muskingum Island Well Plugging Project. The project is located off the shore of Muskingum Island, in Wood County, West Virginia. The proposed activity is located at approximately 39.3647991° N, 81.5124644° W. Your PCN has been assigned the following file number: LRH-2024-00191-OHR-Ohio River Mile Point 175. Please reference this number on all future correspondence related to this project.

The U.S. Army Corps of Engineers' (Corps) authority to regulate waters of the U.S. is based on the definitions and limits of jurisdiction contained in 33 CFR Part 328 and 33 CFR Part 329. Section 404 of the Clean Water Act (Section 404) requires a DA permit be obtained prior to discharging dredged and/or fill material into waters of the U.S., including wetlands. Section 10 of the Rivers and Harbors Act of 1899 (Section 10) requires a DA permit be obtained for any work in, on, over, or under a navigable water. The Ohio River is a traditional navigable waterway subject to regulation under both Section 404 and Section 10.

The proposed project, as described in the submitted information, has been reviewed in accordance with Section 404 and Section 10. Based on your description of the proposed work, and other information available to us, it has been determined that this project will involve activities subject to the requirements of Section 10 and Section 404.

In the submitted PCN materials, you have requested a DA authorization for the permanent and temporary discharges of dredged and/or fill material in association with construction of the Muskingum Island Well Plugging Project. The proposed project would include permanently sealing five (5) orphaned wells adjacent to Muskingum Island in the Ohio River. The proposed action comprises of four (4) primary components: mussel salvage and relocation; gaining access

to wells by dredging space for a work barge; well plugging/sealing; and monitoring mussel status in the proposed relocation area.

Based on the information provided, well access is a requisite in advance of initiating plugging efforts; therefore, the riverbed would be dredged to remove sediment near each well location to afford work barge access. Prior to dredging and regardless of method, sediment curtains would be installed around the overall dredge site to reduce the amount of sediment entering the river. During dredging activities, materials would be removed to the extent required for barge access to the site. Dredged material would be removed and loaded into a hopper barge for lime treatment, temporary storage, and transport to an approved, existing upland landfill. The hopper barge would be anchored to the work barge or moored with spuds adjacent to each well. Based on the information provided, dredging and well site set-up is anticipated to take up to three (3) days per well and up to 15 days in total. The well casings would be cleaned using pressurized water to blow material out of the well and to accommodate insertion of the hose for the installation of liquid concrete, poured in the dry, into each well. Any recovered water and debris would be held in tanks and disposed of as produced water. A minimum of four (4) plugs would be installed at each of the five (5) wells. Following well sealing, the cellar and oil boom would be removed, a monument would be placed to mark the site, and all equipment is removed. Based on the information provided, the well plugging activities would require up to 12 days per well, 60 days in total. As indicated, the purpose of the proposed project is maintenance on existing structures, specifically, sealing five (5) orphaned wells at the subject location.

Based on the provided information, it has been determined the proposed work along the Ohio River, as described above, associated with the Muskingum Island Well Plugging Project meets the criteria for Nationwide Permit (NWP) No. 3 under the January 8, 2026, Federal Register (FR), Reissuance and Modification of NWPs (91 FR 768), provided you comply with all terms and conditions of the enclosed material, the enclosed special conditions, and the general Section 401 Water Quality Certification (401 WQC) issued by the West Virginia Department of Environmental Protection. Please be aware this NWP No. 3 verification does not obviate the requirement to obtain other local, state, and/or federal authorizations required by law for these activities. This verification is valid until the expiration date of the NWPs, unless the NWP authorization is modified, suspended, or revoked. The verification will remain valid if the NWP authorization is reissued without modification or the activity complies with any subsequent modification of the NWP authorization. All of the existing NWPs are scheduled to be modified, reissued, or revoked on March 15, 2031. Prior to this date, it is not necessary to contact this office for re-verification of your project unless the plans for the proposed activity are modified. Furthermore, if you commence or under contract to commence this activity before March 15, 2031, you will have 12 months from the date of the modification or revocation of the NWP to complete the activity under the present terms and conditions of this NWP.

Authorization of work or structures by this permit does not convey a property right, nor authorize any injury or invasion of other rights [33 CFR 320.4(g)]. Within the Huntington District's regulatory boundaries in the State of West Virginia we understand this project may

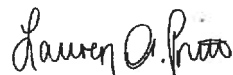

1. All work will be conducted in accordance with the submitted pre-construction notification for the Muskingum Island Well Plugging Project received in this office on August 7, 2025.
2. Enclosed is a copy of Nationwide Permit 3, which will be kept at the site during construction. A copy of the Nationwide Permit 3 verification, special conditions, and the attached construction plans must be kept at the site during construction. The permittee will supply a copy of these documents to their project engineer responsible for construction activities.
3. Upon completion of the activity authorized by these Nationwide Permit 3 verification, the enclosed certification must be signed and returned to this office along with as-built drawings showing the location and configuration, as well as all pertinent dimensions and elevations of the activity, including the photographs of the restored temporarily affected aquatic resources, authorized under this Nationwide Permit 3 verification.
4. The permittee must notify the United States Army Corps of Engineers (Corps)-Huntington District Waterways Section prior to construction of the Muskingum Island Well Plugging Project. A copy of a Notice to Navigation Information Form for providing the information with contact information is included in the permit package. This form must be completed and returned to the Corps-Huntington District Waterways Section at least 14 days, but no more than 20 days, prior to the start of work. The Corps-Huntington District Waterways Section may be contacted at (304) 399-5694.
5. Prior to the initiation of any work authorized by the Nationwide Permit 3 verification, appropriate site-specific best management practices (BMPs) for sediment and erosion control will be fully implemented during construction activities at the site. Appropriate bank protection measures will be installed in channel or on barren areas requiring erosion control including, but are not limited to, native grasses and forbs, vegetation, and other acceptable clean non-contaminated material. Immediately after completion of the final grading of the land surface, all slopes, land surfaces, and filled areas shall be appropriately stabilized to prevent erosion. The erosion control measures shall remain in place and be maintained until all authorized work is completed and the work areas are stabilized. Construction activities will be performed during low flow conditions to the greatest extent practicable.
6. No area for which grading has been completed will be unseeded or unmulched for longer than fourteen (14) days. All disturbed areas will be seeded and/or revegetated with native species and approved seed mixes (where practicable) after completion of construction activities for stabilization and to help preclude the establishment of non-native invasive species.

All water resources and their buffers, which are to be avoided on-site, must be clearly indicated on the site plans and drawings, demarcated in the field, and protected with suitable material prior to site disturbance. These materials must remain in place and be maintained throughout the construction process.
8. In the event any previously unknown historic or archaeological sites or human remains are uncovered while accomplishing the activity authorized by this nationwide permit authorization, the permittee must cease all work in waters of the U.S. immediately and contact local, state and county law enforcement offices (only contact law enforcement on findings of human remains), the Corps at 304-399-5610 and West Virginia State Historic Preservation Office at 304-558-0220. The Corps will initiate the Federal, state and tribal coordination required to comply with the National Historic Preservation Act and applicable state and local laws and regulations. Federally recognized tribes are afforded a government-to-government status as sovereign nations and consultation is required under Executive Order 13175 and 36 CFR Part 800.
9. This Department of the Army Permit authorization does not authorize the “take” of a threatened or endangered species as defined under the Endangered Species Act (ESA). In the absence of separate authorization (e.g., an ESA Section 10 Permit, a Biological Opinion (BO) with “incidental take” provisions, etc.) from the United States Fish and Wildlife Service (USFWS), both lethal and non-lethal “take” of protected species are in violation of the ESA. The enclosed Biological Opinion, titled *Ohio River Islands Well Plugging, Wood County, West Virginia* (Service File Number 2025-0018623), dated June 20, 2025, contains mandatory terms and conditions to implement the reasonable and prudent measures that are associated with the “incidental take” that is also specified in the BO. Your authorization under this permit is conditional upon your compliance with all of the mandatory terms and conditions associated with incidental take of the attached BO, which terms and conditions are incorporated by reference in this permit. Failure to comply with the terms and conditions associated with incidental take of the BO, where a take of the listed species occurs, would constitute an unauthorized take, and it would also constitute noncompliance with your Corps’ permit. The USFWS is the appropriate authority to determine compliance with the terms and conditions of its Biological Opinion, and with the ESA.
10. In instances where the amount or extent of incidental take is exceeded, any operations causing such a take must cease pending reinitiation.

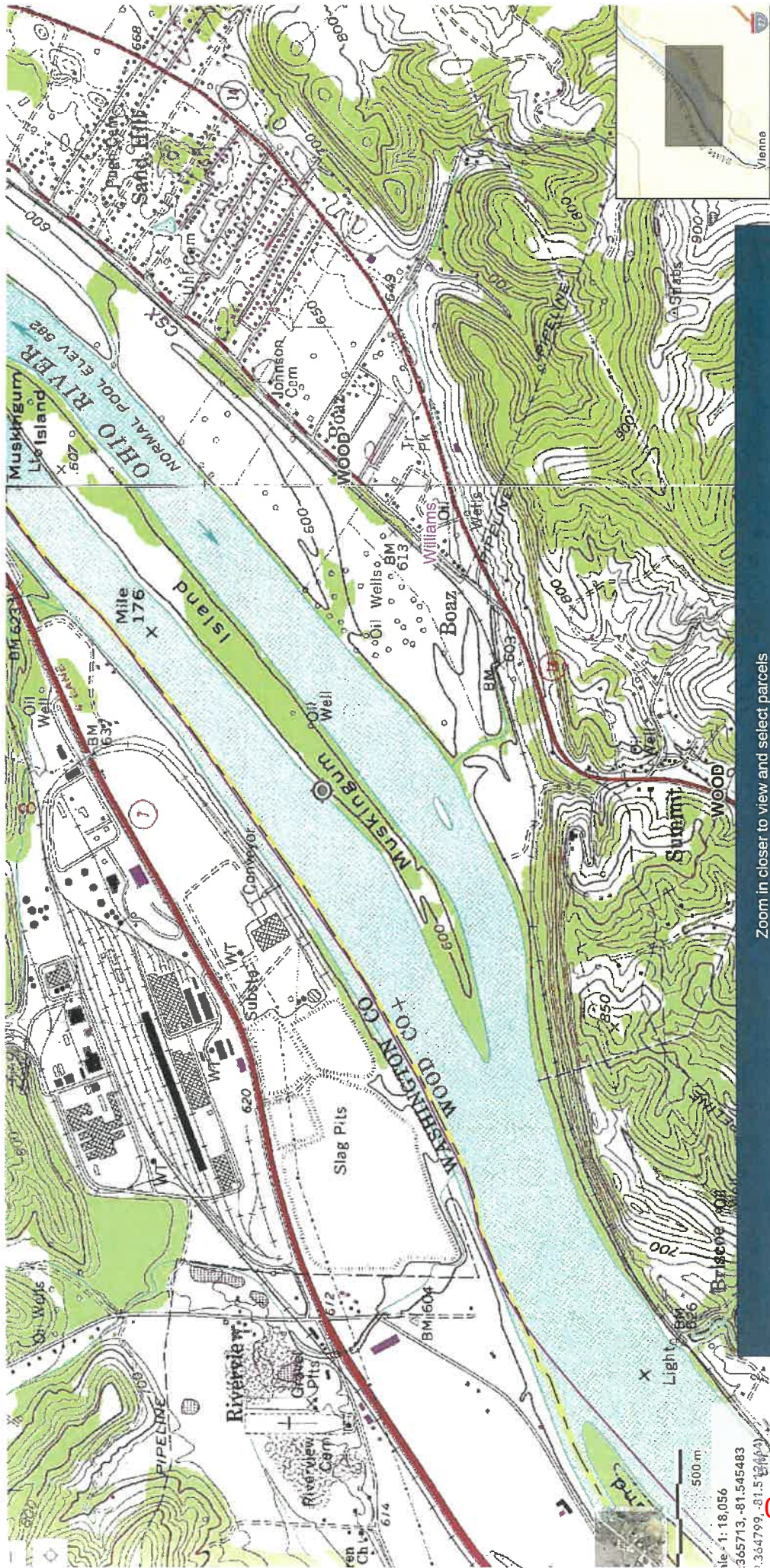

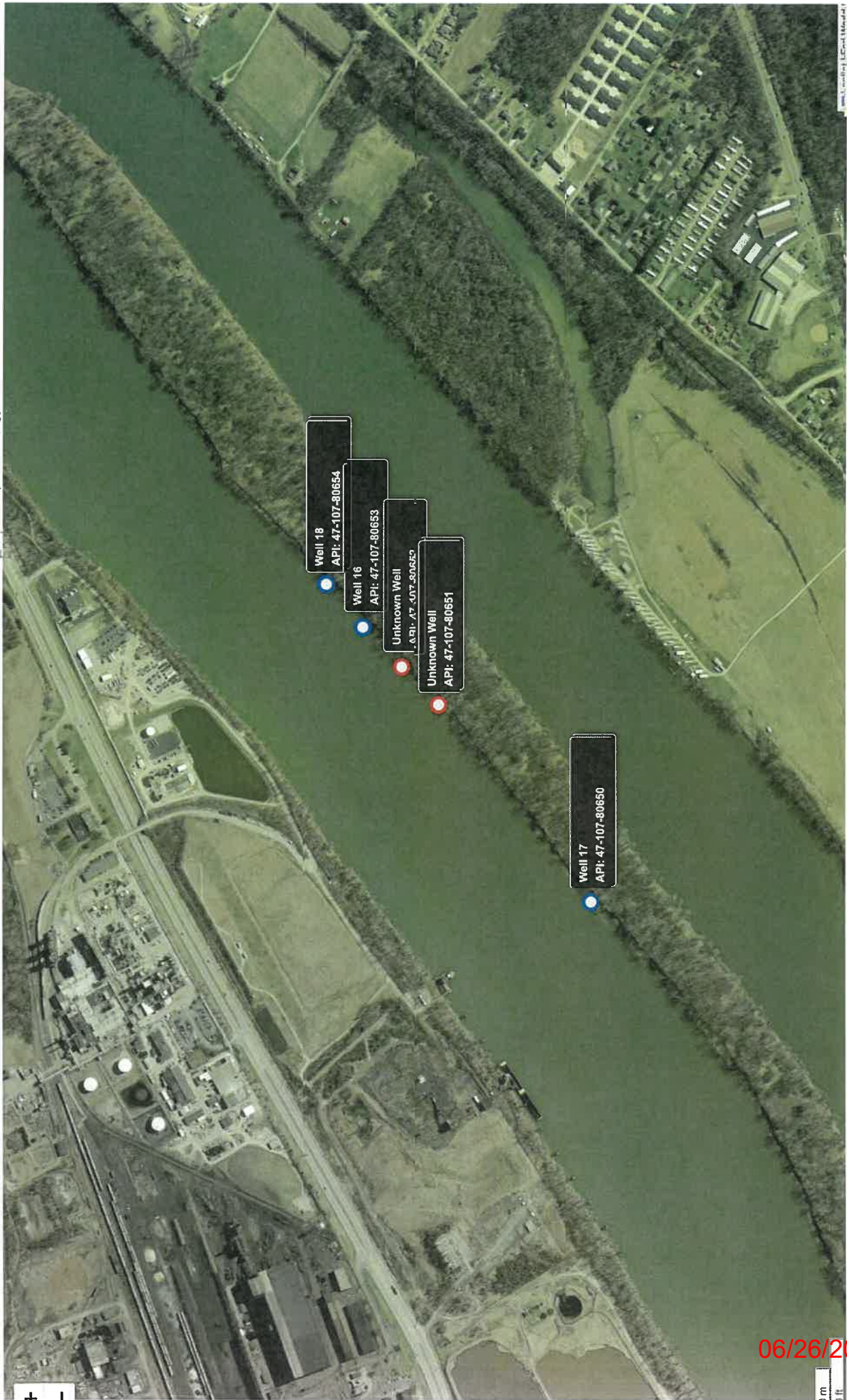
