Jackie Lester and Luke Harris being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by the above named well operator, and participated in the work of plugging and filling the above well say that said work was commenced on the 18th day of May, 2020, and the well was plugged and filled in the following manner:

Casing was rotten and would not pull. Pipe was milled to 82'. Hole was cleaned out to 4,474'. Cemented from 4,474' to 3,850'. Gelled hole from 3,850' to 1,600'. Perforated and cemented 1,600' to 1,450' with 60 sacks of cement. Gelled hole from 1,450' to 1,200'. Cemented 1,200' to 0' with 440 sacks of cement. Erected monument.

Description of monument: 10 inch welded pipe with API number. and that the work of plugging and filling said well was completed on the 5th day of June, 2020.

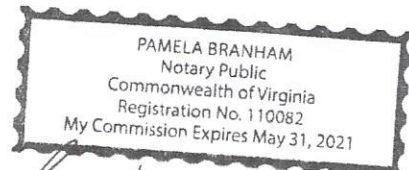
