In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

CONDITIONS


- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.
- 4. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing.

- 1. Notify State Inspector, Brian Warden (304)-205-3229– brian.warden@wv.gov 24 hours prior to commencing operations.
- 2. Prep MC-36 location.
- 3. MIRU service rig, steel pits, and other ancillary equipment.
- 4. Blow well down, and TOOH w/ production tubing and anchor packer.
- 5. RIH w/ work string to ~1750'
- 6. Pump 30 BBI 6% gei.
- 7. Set 200' cement plug F/ 1750' T/ 1550'. (Csg shoe @ 1672').
- 8. TOOH to 1000', WOC 8 hrs, RIH & tag plug, add cement if needed.
- 9. 6-5/8" & 8-1/4" Casings (if present) will be ripped and removed from well bore where free. The following cement plugs set will be set, with the order depending on where casing is free and able to be removed. 6% gel will be spotted between each plug.
 - a. 100' plug across from location of ripped 6-5/8" casing.
 - b. 100' plug F/ 1200' T/ 1000'. Csg ripped or perforated at ~1130' if csg is still present.
 - c. 200' elevation plug F/ 700' T/ 500' (Elevation @ 561'). Csg ripped or perforated at ~600' if csg is still present.
 - d. 100' plug across from location of ripped 8-1/4" casing.
 - e. 100' coal plug F/ 450' T/ 350'. Csg ripped or perforated at 450' if csg is still present.
- 10. Attempt to POOH w/ 10" csg if present.
- 11. Pump 100' plug F/ 100' T/ surface'. Csg ripped or perforated at 50' if csg is still present.
- 12. Erect a monument to WV DEP specifications (CSR 35-4-5.5 sub "b").
- 13. Reclaim location and roads to WV DEP Specifications.

The well operator named on page WW-4A is applying for a permit from the State to plug and abandon a well. 
