#### WELL WORK PLUGGING PERMIT

#### Plugging

This permit, API Well Number: 47-1501595, issued to TRIAD HUNTER, LLC, is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. The above named operator will also file, as required in WV Code 22-6-23, an affidavit on form WR-38 by two experienced persons in the operator's employment and the Oil and Gas inspector that the work authorized under this permit was performed and a description given. Failure to abide by all statutory and regulatory provisions governing all duties and operations here under may result in suspensions or revocation of this permit and in addition may result in civil and/or criminal penalities being imposed upon the operator.

#### PERMIT CONDITIONS

West Virginia Code § 22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

#### **CONDITIONS**

- 1. If the operator encounters an unanticipated void, or an anticipated void at an unanticipated depth, the operator shall notify the inspector within 24 hours. Modifications to the casing program may be necessary to comply with W. Va. Code § 22-6-20, which requires drilling to a minimum depth of thirty feet below the bottom of the void, and installing a minimum of twenty (20) feet of casing. Under no circumstance should the operator drill more than fifty (50) feet below the bottom of the void or install less than twenty (20) feet of casing below the bottom of the void.
- 2. Pursuant to 35 CSR § 4-19.1.a, at the request of the surface owner all water wells or springs within 1000 feet of the proposed well that are actually utilized for human consumption, domestic animals or other general use shall be sampled and analyzed.
- 3. Pursuant to 35 CSR § 4-19.1.c, if the operator is unable to sample and analyze any water well or spring within one thousand (1,000) feet of the permitted well location, the Office of Oil and Gas requires the operator to sample, at a minimum, one water well or spring located between one thousand (1,000) feet and two thousand (2,000) feet of the permitted well location.
- 4. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 5. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 6. During the surface casing and cementing process, in the event cement does not return to the surface, or any other casing string that is permitted to circulate cement to the surface and does not return to the surface, the oil and gas inspector shall be notified within twenty-four (24) hours.
- 7. Well work activities shall not constitute a hazard to the safety of persons.

#### Plugging Procedure Attachment (Wells with 8 5/8" Casing)

MIIRU service rig and flowback tank; blow well down.

- 1. Pull tubing and rods OOH.
- 2. Check total depth with sandpump; clean out hole below bottom perforation.
- 3. Run 2 3/8" tubing below bottom perforation.
- 4. (Bottom Hole Plug) Mix/Pump 20 sacks Class A cement, (23.6 cu. ft.), 1/4 lb.flocele/sk., no CaCl.
- 5. Displace cement through tubing with gel water.
- 6. Pull 2 3/8" tubing OOH.

- 7. RIH with casing cutter tool, check depth of 1st plug and find 4 1/2" cement top ( free pipe ).
- 8. Cut-off 4 1/2" casing just above the cement top, break circulation, and pull one jt. of casing OOH.
- 9. (Cut Plug) Mix/Pump 30 sacks Class A cement, (35.4 cu. ft.), 1/4 lb. flocele/sk.,no CaCl.
- 10. Displace cement through casing with gel water.
- 11. Pull 4 1/2" casing up to the subsea elevation depth.
- 12. ( Elevation Plug ) Mix/Pump 30 sacks of Class A cement, (35.4 cu. ft.), 1/2 lb. flocele/sk., no CaCl
- 13. Displace cement through casing with gel water 260 160
- 14. Pull 4 1/2" casing to 100 feet below surface.
- 15. (Surface Plug) Mix/Pump 30 sacks of Class A cement, (35.4 cu. ft.), 1/2 lb. flocele/sk., no CaCl.
- 16. Circulate cement to surface.
- 17. Pull remaining joints of 4 ½" casing OOH. Top load annulus with Class A cement to surface.
- 18. Weld a three foot monument pipe on to the existing casing. Fill monument pipe with cement and attach identification plate to monument pipe.
- 19. RDMO service rig and supporting equipment.
- 20. Reclaim well site and lease road.
