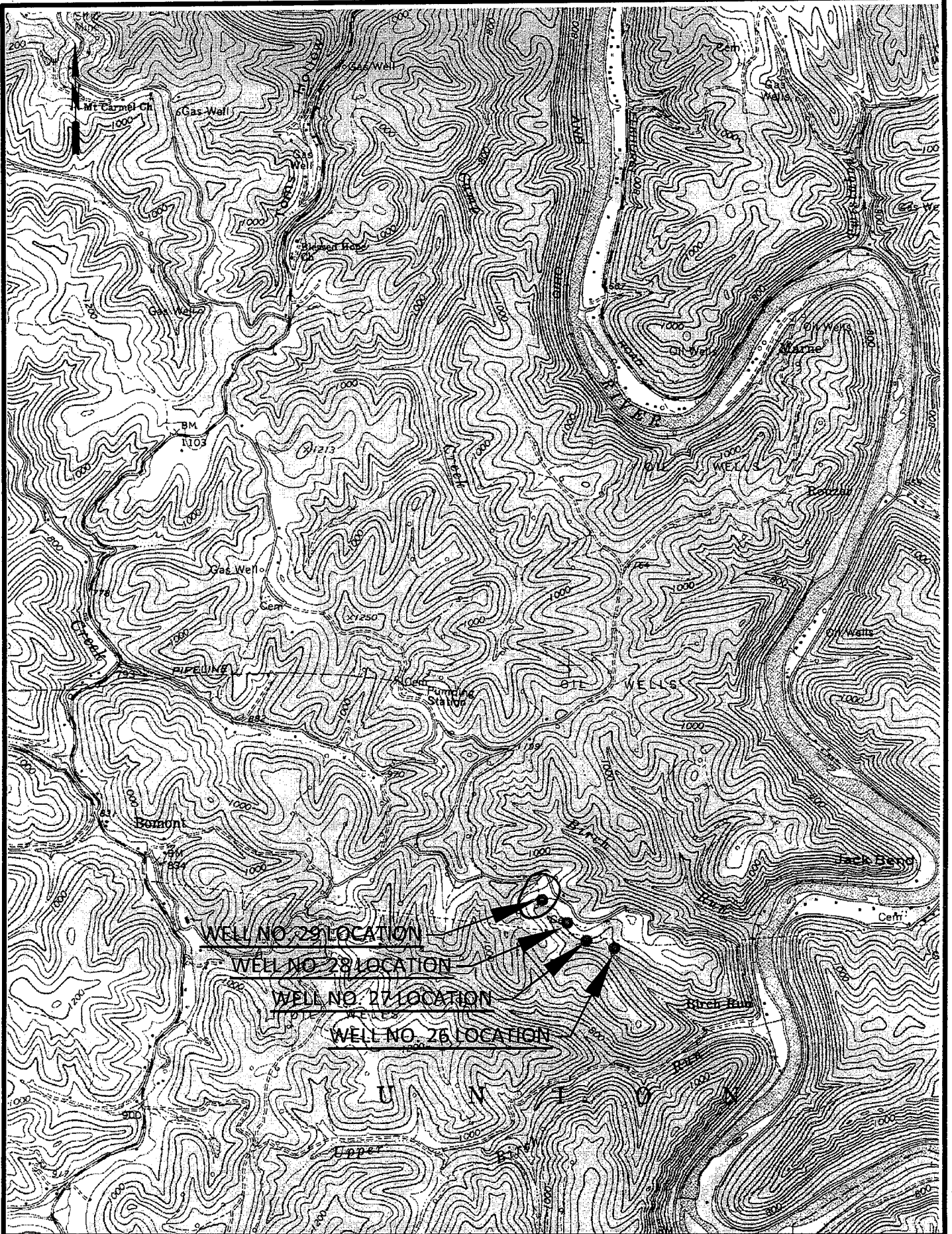

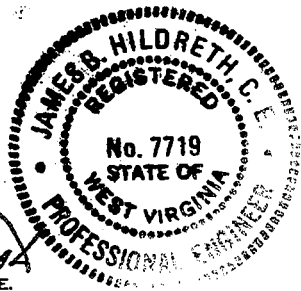


ELKHURST QUADRANGLE
