#### WELL WORK PLUGGING PERMIT

#### Plugging

Failure to abide by all statutory and regulatory provisions governing all duties and operations here under may result in suspensions or revocation of this permit and in addition may result in civil and/or criminal penalities being imposed upon the operator.

- 1. Verify TD. TIH with 2-3/8" EUE tubing. Circulate 6% gel to surface.
- 2. Pump cement plug from TD to 2097'. TOH with 2-3/8" EUE. Wait on cement.
- 3. Verify cement top. Free point, cut & pull 5-3/16" above cement (~2100').
- 4. TOH with 5-3/16 casing.
- 5. Attempt to pull 6-5/8" (1766'), if unable to pull, free point and cut @ 1000'.
- 6. TOH with 6-5/8" casing.
- 7. Attempt to pull 8-1/4" casing (1090').
- 8. If unable to pull free point and cut @ 150' perforate all casing every 200'.
- 9. Pull 10" casing (153').
- 10. TIH w/ 2-3/8" EUE work string. Pump 100' cement plugs across all casing cuts.

You have FIVE (5) DAYS after the filing date to file your comments. Comments must be filed in person or received in the mail by the Chief's office by the time stated above. You may call the Chief's office to be sure of the date. Check with your postmaster to ensure adequate delivery time or to arrange special expedited handling. If you have been contacted by the well operator and you have signed a "voluntary statement of no objection" to the planned work described in these materials, then the permit may be issued at any time.

Comments must be in writing. Your comments must include your name, address and telephone number, the well operator's name and well number and the approximate location of the proposed well site including district and county from the application. You may add other documents, such as sketches, maps or photographs to support your comments.

The Chief has the power to deny or condition a well work permit based on comments on the following grounds:

- 1) The proposed well work will constitute a hazard to the safety of persons.
- 2) The soil erosion and sediment control plan is not adequate or effective;
- 3) Damage would occur to publicly owned lands or resources;
- 4) The proposed well work fails to protect fresh water sources or supplies;
- 5) The applicant has committed a substantial violation of a previous permit or a substantial violation of one or more of the rules promulgated under Chapter 22, and has failed to abate or seek review of the violation...".

If you want a copy of the permit as it is issued or a copy of the order denying the permit, you should request a copy from the Chief.




