Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

PERMIT CONDITIONS

West Virginia Code §22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

CONDITIONS

- 1. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 2. Well work activities shall not constitute a hazard to the safety of persons.
- 3. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing.

 - 1. Notify Inspector Jeff Propst @ (681) 990-2569, 48 hrs prior to commencing operations.
 - Check and record pressures on csg/tbg.
 - 3. Pull and lay down rods and 2" tbg string.
 - 4. Check TD w/ wireline and confirm shoe depth of casing and top of cement in inner most casing string with CBL.
 - 5. Run into attainable bottom. Kill well as needed with 6% bentonite gel and fill rat hole. Pump at least 10 bbls gel. Pump 600' Class A/L cement plug. (Bottom hole plug) Tag TOC. Top off as needed.
 - 6. If the casing is not run to TD, TOOH w/ tbg to above cement plug. Pump 6% bentonite gel RECEIVED Office of Oil and Gas
 - 7. If the casing is not run to TD, TOOH w/ tbg to 50' below casing shoe. Pump 100' Class A/L 0 7 2025 cement plug 50' in/out of csg shoe (csg shoe plug).

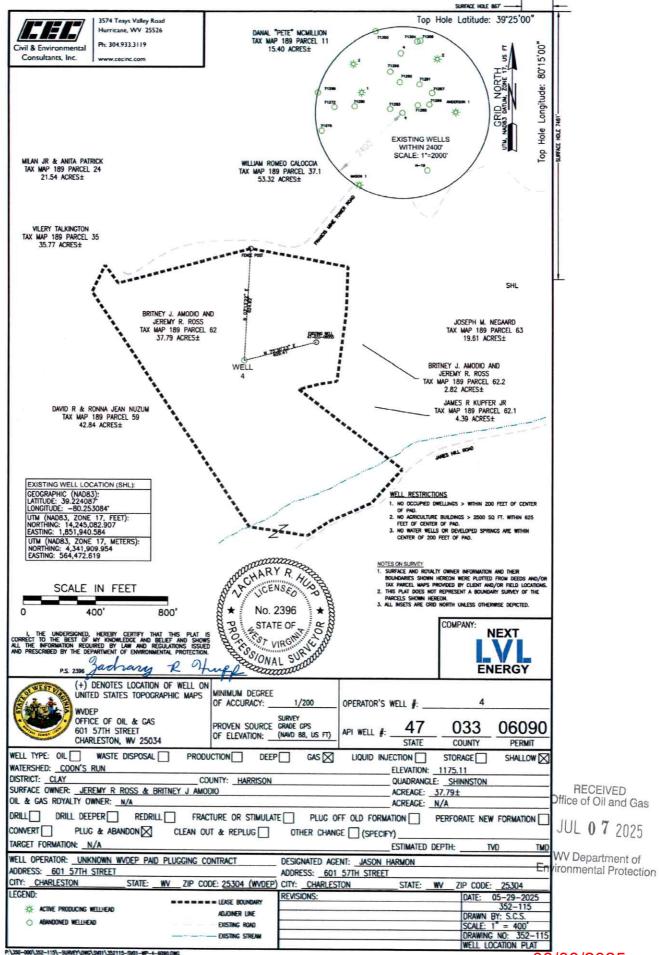
- 8. Pump 6% bentonite gel from top of shoe plug to bottom of production elevation plug.
- 9. TOOH w/ tbg to 1350'. Pump 450' Class A/L cement plug from 1350' to 900' (elevation plug and potential salt water plug).
- 10. TOOH w/ tbg to 900'. Pump 6% bentonite gel from 900' to 400'.
- 11. Free point csg. Cut and TOOH. Set 100' Class A/L cement plug across csg cut. 50' in/out of cut. Do not omit any plugs listed below. Perforate as needed.
- 12. If there is another casing string in the well, free point csg. Cut and TOOH. Set 100' Class A/L cement plug across csg cut. 50' in/out of cut. Do not omit any plugs listed below.
 Perforate as needed.
- 13. TOOH w/ tbg to 400'. Pump 400' Class A/L cement plug from 400' to surface (surface and coal plug).
- 14. Reclaim location and well road to WV DEP specifications and erect P&A well monument.

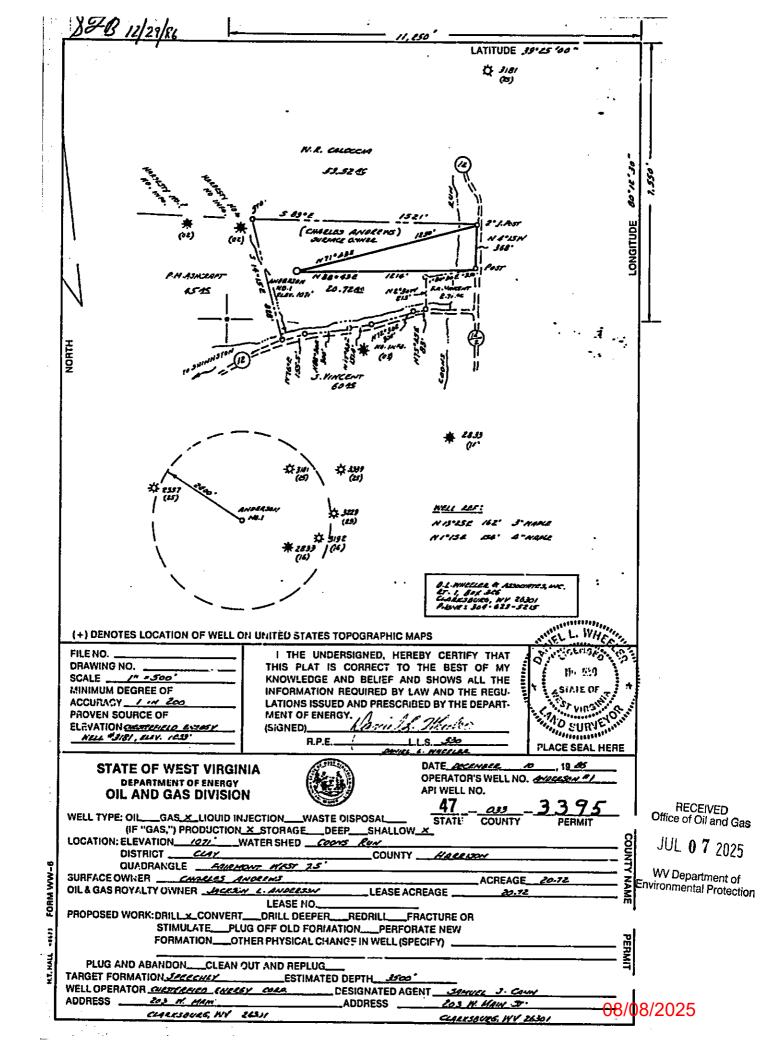

REPORT OF THE OFFICE

In response to industry requests, the West Virginia Department of Environmental Protection, Office of Oil and Gas has reviewed the proposed use of American Petroleum Institute (API) Class L cement to be used in place of API Class A cement for well plugging.

FINDINGS OF FACT

- 1. On July 28, 2022, Diversified Gas & Oil Co. (DGO) submitted a variance request from Legislative Rule 35CSR4 for the use of API Class L cement in place of API Class A cement, relating to the plugging of conventional wells.
- 2. Laboratory analysis submitted by DGO on July 28, 2022, indicates API Class L cement is comparable to API Class A cement and thereby satisfies the requirements of the West Virginia Code.

Contemporaneously, the Chief of the Office of Oil and Gas also chose to consider a variance to Legislative Rule 35CSR8 Section 20.1., for the use of API Class L cement in Wy Department of Environmental Part of place of API Class A cement, relating to the plugging of horizontal wells.

Pursuant to Legislative Rule 35CSR4, Section 18 and Legislative Rule 35CSR8, Section 14, the Chief of the Office of Oil and Gas may grant a variance from any requirement of these rules.

ORDER

It is ordered that the Class L cement product approved and monogramed by API is approved for use in place of API Class A cement for well plugging subject to the provisions of Legislative Rule 35CSR4 and Legislative Rule 35CSR8.
