#### WELL WORK PERMIT Re-Work

This permit, API Well Number: 47-4102757, issued to DOMINION TRANSMISSION INC, is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Please be advised that form WR-35, Well Operators Report of Well Work is to be submitted to this office within 90 days completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

In addition to the applicable requirements of this permit, and the statutes and rules governing oil and gas activity in WV, this permit may contain specific conditions which must be followed. Permit conditions are attached to this cover letter.

Per 35CSR-4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0499 ext. 1654.

#### **PERMIT CONDITIONS**

West Virginia Code § 22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

#### **CONDITIONS**

- 1. If the operator encounters an unanticipated void, or an anticipated void at an unanticipated depth, the operator shall notify the inspector within 24 hours. Modifications to the casing program may be necessary to comply with W. Va. Code § 22-6-20, which requires drilling to a minimum depth of thirty feet below the bottom of the void, and installing a minimum of twenty (20) feet of casing. Under no circumstance should the operator drill more than fifty (50) feet below the bottom of the void or install less than twenty (20) feet of casing below the bottom of the void.
- 2. Pursuant to 35 CSR § 4-19.1.a, at the request of the surface owner all water wells or springs within 1000 feet of the proposed well that are actually utilized for human consumption, domestic animals or other general use shall be sampled and analyzed.
- 3. Pursuant to 35 CSR § 4-19.1.c, if the operator is unable to sample and analyze any water well or spring within one thousand (1,000) feet of the permitted well location, the Office of Oil and Gas requires the operator to sample, at a minimum, one water well or spring located between one thousand (1,000) feet and two thousand (2,000) feet of the permitted well location.
- 4. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 5. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 6. During the surface casing and cementing process, in the event cement does not return to the surface, or any other casing string that is permitted to circulate cement to the surface and does not return to the surface, the oil and gas inspector shall be notified within twenty-four (24) hours.
- 7. Well work activities shall not constitute a hazard to the safety of persons.
- 8. If well work related activities require the use of water obtained by withdrawals from waters of this state in amounts that exceed two hundred ten thousand gallons during any thirty day period, the operator is required to consult, and adhere to, the guidance provided by DEP's Water Withdrawal Guidance Tool prior to any water withdrawals.

#### Purpose:

Run new 2-7/8" K55 production casing string, cemented to surface to resolve integrity issues on existing 5-1/2" casing.

#### Well Information:

10-3/4" Casing set at 20' (1901)
7" Casing set at 2126' (1901)
5-1/2" 17# K55 Casing set at 2234' (1943)
Perforated at 2000' and 1765' for squeeze job and cemented to surface with 110sx in 1962
Gantz (OH completion) 2423'- 2450'
Well TD is 2467'

#### Procedure:

- Prepare roads and location as needed to allow for service rig to access location per E&S Plan.
   Install all required E&S controls. Stockpile topsoil and seed and mulch pile. Excavate around well and install well cellar around wellhead and line with plastic.
- 2. Set retrievable plug in bottom of 5-1/2" casing. Load hole with fluid and dump 150 lbs of sand on top of plug.
- 3. Bond Log 5-1/2" casing.
- 4. Remove and replace existing wellhead valves. Try to remove 5-1/2" pup, plate of between 7" and 10-3/4" casing strings install 2" weldolets, nipple, and valve. Plat off between 5-1/2" and 7" 2" weldolets, nipple, and valve. Install 7-1/16" 2M x 5-1/2" 8RD TCM tubing head with 2" LPO.
- 5. Notify State Oil and Gas Inspector of rig move. MIRU service rig, mud tank, and auxiliary equipment. Install 7-1/16" 2M+ BOP with and test to 2000psi.
- 6. Build mud system to desired weight based on field pressure.
- 7. TIH circulate sand of plug, run sweep and retrieve plug.
- 8. Based on Bond Log results and any possible annular gas seen at surface during top joint change out prepare to cut window in 5-1/2" and 7" casing.
- 9. Clean out well to TD to 2,467'
- 10. Clean and inspect threads on 3-1/2" 10RD 9.2# J/K-55 tubing.
- 11. Pick up 5-1/2" packer and 3-1/2" pump out cement sleeve and 3-1/2" tubing and set at 2,225'
- 12. MIRU cementing unit. RU on 3-1/2" tubing. Circulate wellbore for 1 hour with mud taking returns through 2" outlets in casing head. Cement well to surface as follows: 10bbls of mud flush, Cement Class A 15.4 ppg. 10% excess inside casing if window is cut pump 15% extra. Displace with fresh water. Cement weight should be based on maximum differential pressure of packer. Secure well. WOC a minimum of 12 hrs.

- 13. Install 7-1/16" 2M x 3-1/8" 2M DSA ,3-1/8" 2M Master Gate Valve, 3-1/8" 2M x 3-1/8" 2M Studded Tee, and 3-1/8" 2M Blind Flange tapped 3-1/2" 8RD, 3-1/8" Side Gate Valve and 4-1/16" x 3-1/8" SSA
- 14. Bond Log 3-1/2".
- 15. Rig up 4-1/16" with 1502 integral flange and pressure up to pump out disc in cementing sleeve.
- 16. Rig up and swab well down until it kicks off, flow well until it cleans up.
- 17. RDMO service rig and haul fluid to disposal
- 18. MIRU logging truck and run casing inspection suite.
- 19. Reclaim site.

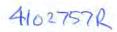

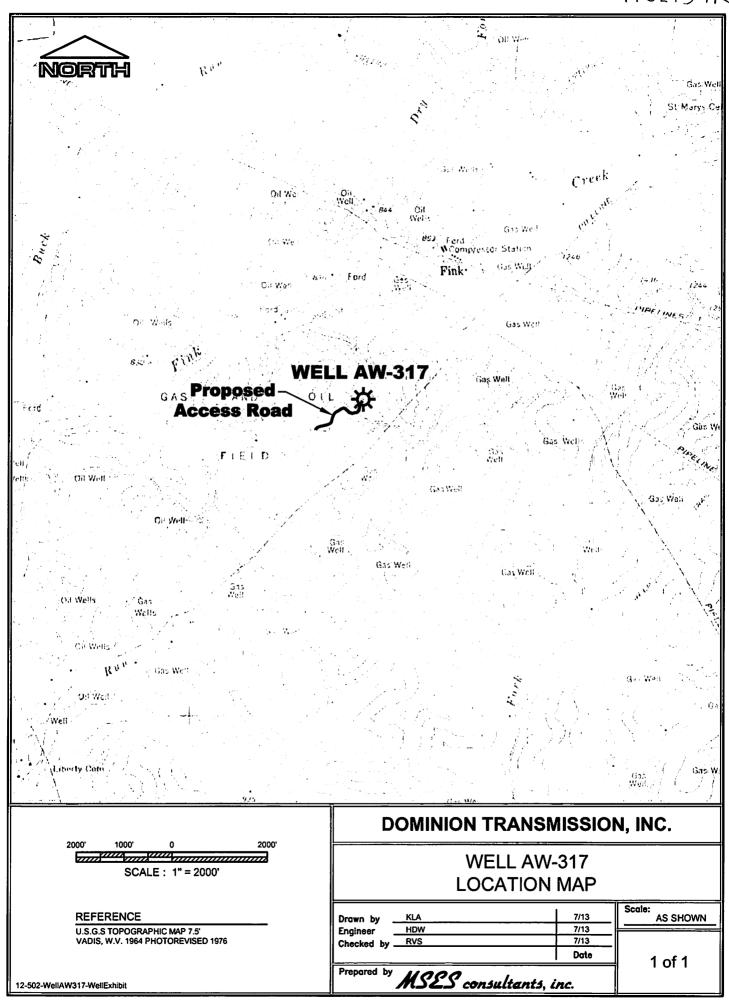

#### NOTICE TO SURFACE OWNERS

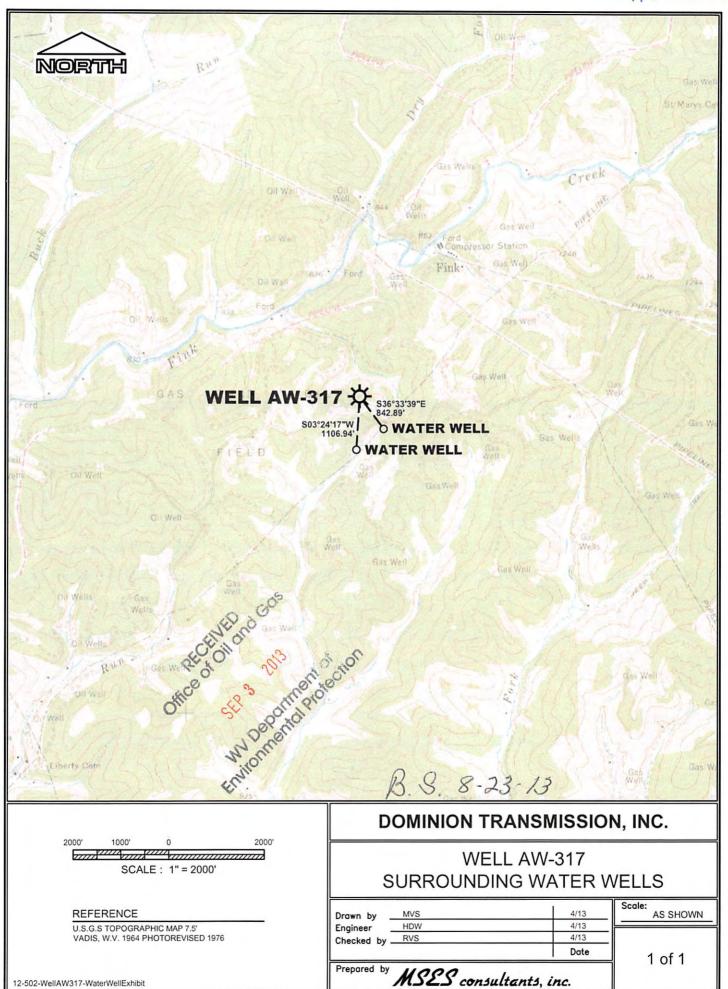
