Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

PERMIT CONDITIONS

West Virginia Code §22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

CONDITIONS

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.
- 4. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing.

- 1. Notify Inspectors Strader Gower (304) 993 6188 strader.c.gower@wv.gov prior to beginning operations.
- 2. Check and record pressure on all casing, notify engineer of recorded pressure.
- 3. Rig up wireline lubricator, RIH w/ gauge ring to 6,500' if good, run wireline set a CIBP @6,500' MD above the Marcellus. Set CIBP. If unable to get to set depth, EQT office will call DEP to discuss options.
- POOH w/ wireline and load well with fresh water if not full. Do not exceed 5,000psi Hydrostatic pressure plus surface pressure together. Ensure leak-off is not more than 10% in thirty minutes.
- 5. RIH and set second CIBP 10' above the first @6,490' MD
- 6. RIH with segmented bond log and pull log from CIBP to surface. Share results with EQT and DEP reps.
- 7. TIH w/ tubing to top CIBP @ 6,490', Pump 6% gel from 6,490' to 2,000', set 500' Class A or Class L cement plug from 6,490' to 5,990' TOOH w/ tubing.
- 8. If bond log allows it TOOH w/ tubing to 5,000', set 200' Class A or Class L cement plug from 5,000' to 4,800', TOOH w/tubing. Let cement set for 8 hours
- 9. Contact EQT rep and discuss 5 1/2" casing cut depths. If 5 1/2" csg cut and pull.
- 10. TIH w/ tubing to 50' inside and 200' outside of 5 ½" casing cut, cement casing cut w/ Class A or Class L cement plug. Let cement cure for 8 hours.
- 11. TIH w/ tubing to 2,686', set 400' Class A or Class L cement plug from 2,686' to 2,286'.
- 12. TIH w/ tubing to 1,300', set 300' Class A or Class L cement plug from 1,300' to 1,100'.
- 13. TIH w/ tubing to 400', set 400' Class A or Class L cement plug from 400' to surface
- 14. Remove any surface wellhead equipment.
- 15. Install 6" or greater monument w/ EQT API number Date plugged 5' above surface per DEP regulation.

REPORT OF THE OFFICE

In response to industry requests, the West Virginia Department of Environmental Protection, Office of Oil and Gas has reviewed the proposed use of American Petroleum Institute (API) Class L cement to be used in place of API Class A cement for well plugging.

FINDINGS OF FACT

- On July 28, 2022, Diversified Gas & Oil Co. (DGO) submitted a variance request from Legislative Rule 35CSR4 for the use of API Class L cement in place of API Class A cement, relating to the plugging of conventional wells.
- Laboratory analysis submitted by DGO on July 28, 2022, indicates API Class L cement is comparable to API Class A cement and thereby satisfies the requirements of the West Virginia Code.
- 3. Contemporaneously, the Chief of the Office of Oil and Gas also chose to consider a variance to Legislative Rule 35CSR8 Section 20.1., for the use of API Class L cement in place of API Class A cement, relating to the plugging of horizontal wells.

 On August 18, 2022, the Office of Oil and Gas provided public notice of acceptance of public comments on the variance consideration. During the 20-day public comment period, no comments were received.

CONCLUSIONS OF LAW

Pursuant to Article 6 and Article 6A, Chapter 22 of the Code of West Virginia, the Office of Oil and Gas has jurisdiction over the subject matter, and the persons interested therein, and jurisdiction to promulgate the hereinafter prescribed Order.

Pursuant to Legislative Rule 35CSR4, Section 18 and Legislative Rule 35CSR8, Section 14, the Chief of the Office of Oil and Gas may grant a variance from any requirement of these rules.

ORDER

It is ordered that the Class L cement product approved and monogramed by API is approved for use in place of API Class A cement for well plugging subject to the provisions of Legislative Rule 35CSR4 and Legislative Rule 35CSR8.




