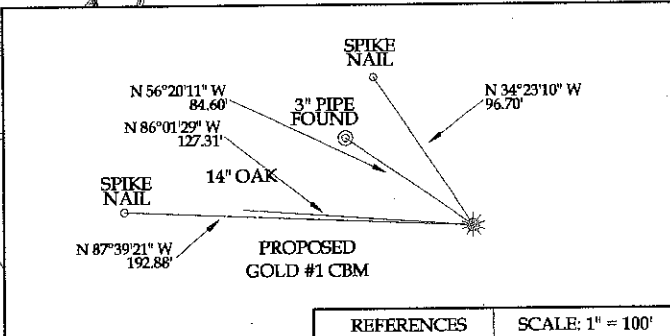
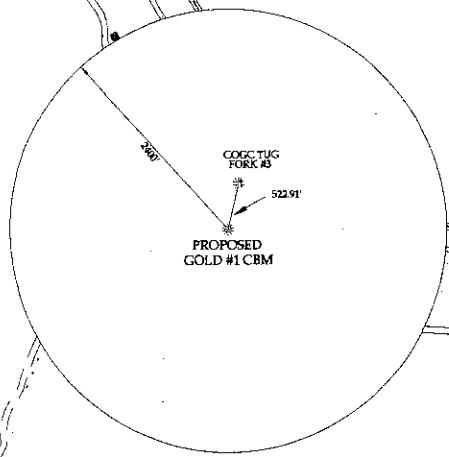


PROPOSED GARNET #1 CBM
