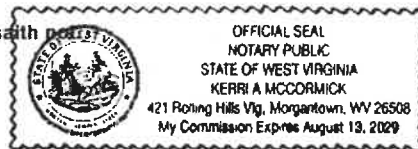

YEARSLEY and JOHN CAMPBELL being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by West Virginia Land Resources, Inc. well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 21st day of June, 2025 and that the well was plugged in the following manner:

Cleaned a 12 1/4" hole from surface to 294'. Reduced to 9 7/8" bit and cleaned a 9 7/8" hole from 294' to 1247'. Cleaned a 9 7/8" hole through the Pittsburgh Coal Seam (997' – 1004'). Left 20' of 16" Conductor Casing in the hole from surface to 20'. Cemented hole from 1247' to surface as follows: Cemented hole from 1247' to 797' using 240 sacks of Thixotropic Cement with Green Dye and Gas Blocker Additive. Cemented hole from 797' to surface using 450 sacks of Expandable Cement. Cement did circulate at the surface.
