Dear Fred.

I wen't to twenty mile Creek of Nicholas county today to check on the pollution complaint you received from Mr Mike Hill.

The well where the pollution occurred, was drilled by W.B.C. Exp. & Dev.co. of Parkersburg W.V. Permit #47-067-0559, a coal haul road of Mr. Hills was used to get to the location.

Due to the warm weather, thawing had begun and along with some rain the road was rutted out to some extent when W.B.C. moved the service rig and Frac. trucks in to finish up the well, however pickups were still able to get over it and Mr Hill continued to haul coal, BBB but he got quite mad at W.B.C.

The Pit for the well was built close a small stream, which was dry when the well was drilled, but due to the rainfall it got quite a lot of water in it, which was washing at the base of the pit, to keep it from washing out all at once they drained the pit and built a new one near the high wall.

When Mr. Hill saw what they were doing he called Mr. Johnson who gave them a ticket for polluting and carrying mud out on the hard road and had then to haul crushed stone for the haul road (which they were still doing today)

This is about all I could find out and it was from W.B.C. men. but after looking over the situation it comfirmed what they told me.

On February 20, 1981, Inspector Rue Schoolcraft investigated a televised report of a spill at well No. 47-067-0559.

Mr. Schoolcraft found that the installation had been made in compliance with the plan submitted to and approved by the Soil Conservation District. The pit had received more fluid from rain and run-offs than was anticipated in the construction, and as a result the retaining wall was taken out. The material in the pit was basically water and some nitrogen compound resulting from the fracture treatment. The fracturing basically was that of a water, nitrogen and sand treatment to open the reservoir for production.

The retaining wall has been re-built and the well now awaits installation of tubing before being placed into production.

The problem was reported by the Hill Enterprise Coal Company that is operating in the area.






