Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

PERMIT CONDITIONS

1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
2. 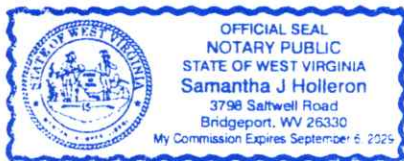

You may call the Chief's office to be sure of the date. Check with your postmaster to ensure adequate delivery time or to arrange special expedited handling. If you have been contacted by the well operator and you have signed a "voluntary statement of no objection" to the planned work described in these materials, then the permit may be issued at any time.

Comments must be in writing. Your comments must include your name, address and telephone number, the well operator's name and well number and the approximate location of the proposed well site including district and county from the application. You may add other documents, such as sketches, maps or photographs to support your comments.

The Chief has the power to deny or condition a well work permit based on comments on the following grounds:

- 1) The proposed well work will constitute a hazard to the safety of persons.
- 2) The soil erosion and sediment control plan is not adequate or effective;
- 3) Damage would occur to publicly owned lands or resources;
- 4) The proposed well work fails to protect fresh water sources or supplies;
- 5) The applicant has committed a substantial violation of a previous permit or a substantial violation of one or more of the rules promulgated under Chapter 22, and has failed to abate or seek review of the violation..."

If you want a copy of the permit as it is issued or a copy of the order denying the permit, you should request a copy from the Chief.

1. List the procedures used for the treatment and discharge of fluids. Include a list of all operations that could contaminate the groundwater.

No fluids will be intentionally discharged.
There is potential for leaks from pipes and hoses.
There could be leaks from tanks or associated fittings.
The equipment may leak.
There could be discharge at the wellhead.
Contamination could result from fertilizer runoff during reclamation.

2. Describe procedures and equipment used to protect groundwater quality from the list of potential contaminant sources above.

Reinforced silt fence (or equivalent) will be placed down hill on the side of hill below the well. The berm and plastic pad liner will be improved prior to the plugging operation. Pad Sumps will be closed during operations, so liquids will be held onsite. Circulated fluids will flow into an open top tank. These fluids will go to appropriate disposal facilities.
During reclamation fertilizer will be spread according to the plan outlined above and when heavy rains are not expected in the near future.

Subsurface groundwater water will be protected as outlined in the operational procedures in this plan.

3. List the closest water body, distance to closest water body, and distance from closest Well Head Protection Area to the discharge area.

400' SE to unnamed drain then 2100' westerly to Sugar Creek then 4500' NW to Middle Island Creek then 11.82 miles to the Ohio River.

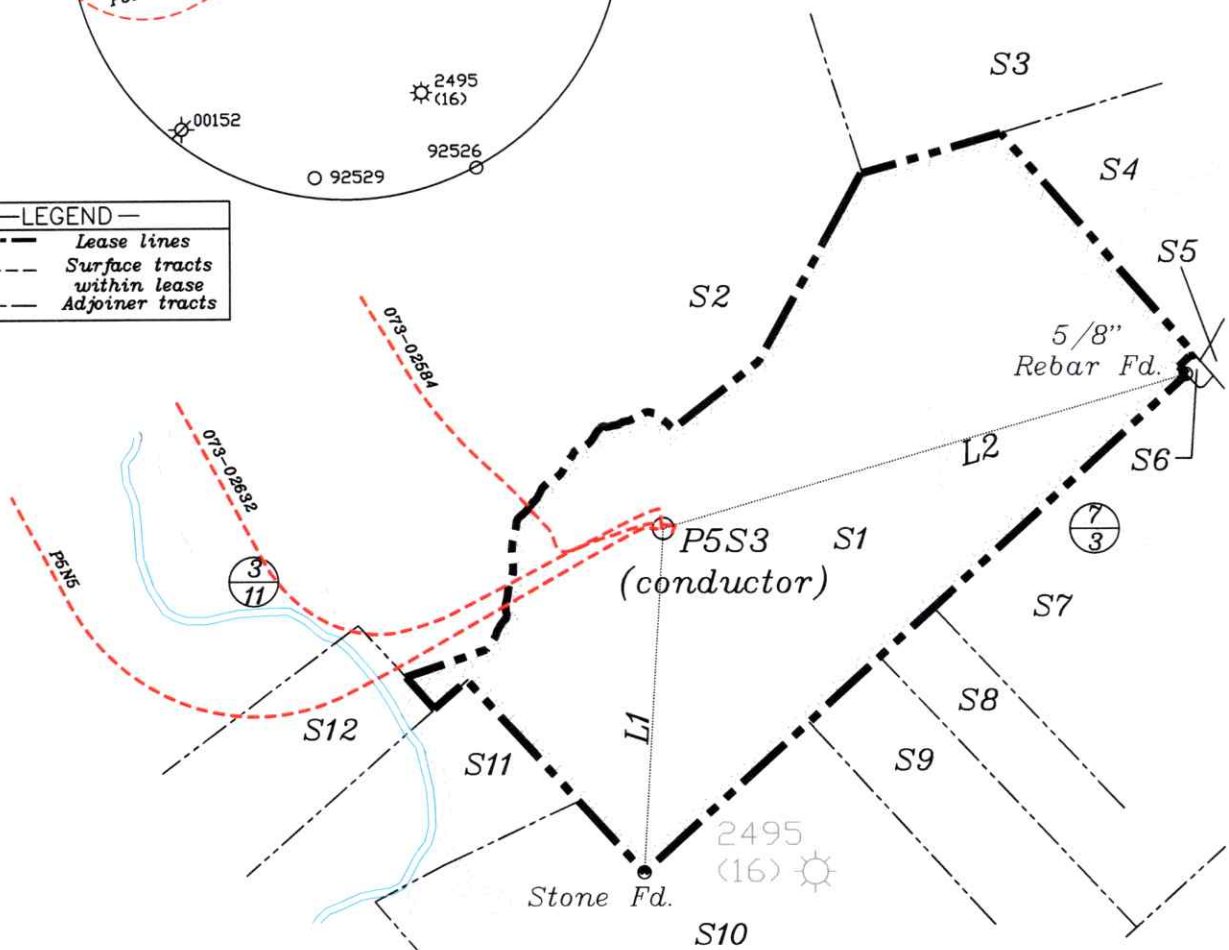


LONGITUDE 81-02-30 W Top Hole 438'

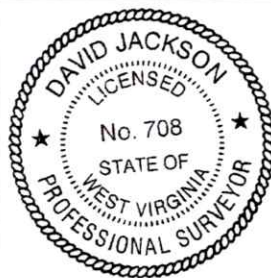
