### Well Operator's Report of Well Work

- COLUMBIA ran a slickline weight to check the TD on 04-17-98. The present TD is recorded as 5,566' GL. The slickline weight set down on fill material at 5,542'GL.
- WellTech Service Rig #20 was moved on location and rigged up 04-17-98.
- The well was killed with a polymer mud system (dextrid and xanathan gum) on 04-21-98.
- A total of 174 joints of tubing (5,466.70' threads off) was pulled and retired on 04-22-98. A well test bomb was recovered on sandline.
- The well was cleaned out to 5,534' KB on 04-24-98.
- Western Atlas ran a Vertilog, directional survey, SBT and GR/N on 04-27-98 and 04-28-98.
- A drillable 7" composite bridge plug was set @ 5,250' on 04-29-98.
- On 04-30-98 Halliburton was rigged up and squeeze pressure was applied (through 2-7/8" drillpipe and a RTTS Packer) to the Chert perforations @ 1,500 to 1,700 psi. The formation took less than 4 bbls fluid.
- On 05-01-98 Halliburton placed a balanced cement plug from 5,250' 4,986', consisting of 50 sks of standard cement w/ 1% Halad 322. A pressure of 1,500 psi was held against the plug losing 145 psi in thirty minutes. The pressure was re-established with 2/10ths-bbl volume.
- The wellhead was modified with new flanged components on 05-04-98 and tested.
- The cement was tagged @ 5,056' on 05-05-98 and the well cleaned out to a TD of 5,536'.
- On 05-14-98 Western Atlas re-perforated the 7" casing @ 6 SPF. 5,417' 5,437', 5,406' 5,417', 5,350' 5,364', 5,330' -5,334' & 5,334 5,340', 5,310' 5,330', 5,290' 5,310'. Atlas set down @ 5,438'
- Halliburton Energy Services was moved in on May 18, 1998. The coiled tubing unit was set up and coiled tubing ran to 5,528' washing out approximately 100' of fill material. Western Atlas ran a gauge ring and set down at a depth of 5,522'. Re-perforating continued @ 6 SPF from 5,464' 5,478', and 5,437' 5,452'.
- The well was acidized 05-19-98 utilizing Halliburton coiled tubing and 15% FE acid across the perforated section using a selective injection packer (SIP).@ 5 foot intervals. Setting and releasing with 30 sets. A total of 309 bbls of 15% FE Acid was used during the job.
- Additives: FE1-A, HAI-81, SCA-130, PENN-88, and HC-2. AVERAGE RATE=1.5BPM AVERAGE TREATING PRESSURE=1,500 PSIG
- Recovered 149 bbls of 309 bbls total fluids on flowback, 5-19-98, through 5-20-98.
- Fluids removed from location and transported for disposal @ Max Environmental (ALS) Pittsburgh PA on 5-25-98.
- Solids resulting from cement operation were disposed of 5-12-98 @ NORTHWESTERN LANDFILL, INC., Parkersburg, WV 26101.
- Well Work Completed 05-26-98.
