






WELL SITE PLAN

Comments: Access to the well site will be gained by constructing approximately 300 feet of new access road, beginning at a junction point in the Ritchie County Route 04/05/2024 access road will be sloped at 2-3% towards the open ditch. All outlets of drainage structures and ditches will be to stable areas. The well location will be located in a flat cleared area. All brush and timber will be removed from the area to be disturbed prior to any earth moving activities. The road and well site will be brought to desired grade with erosion control structures being installed in conjunction with the grading. Under most conditions, the preceeding plan will be followed; however, due to lease restrictions, surface owner request and weather conditions, etc., the plan may be altered. Subsequently, the proper exosion and sediment control measures will be installed.




