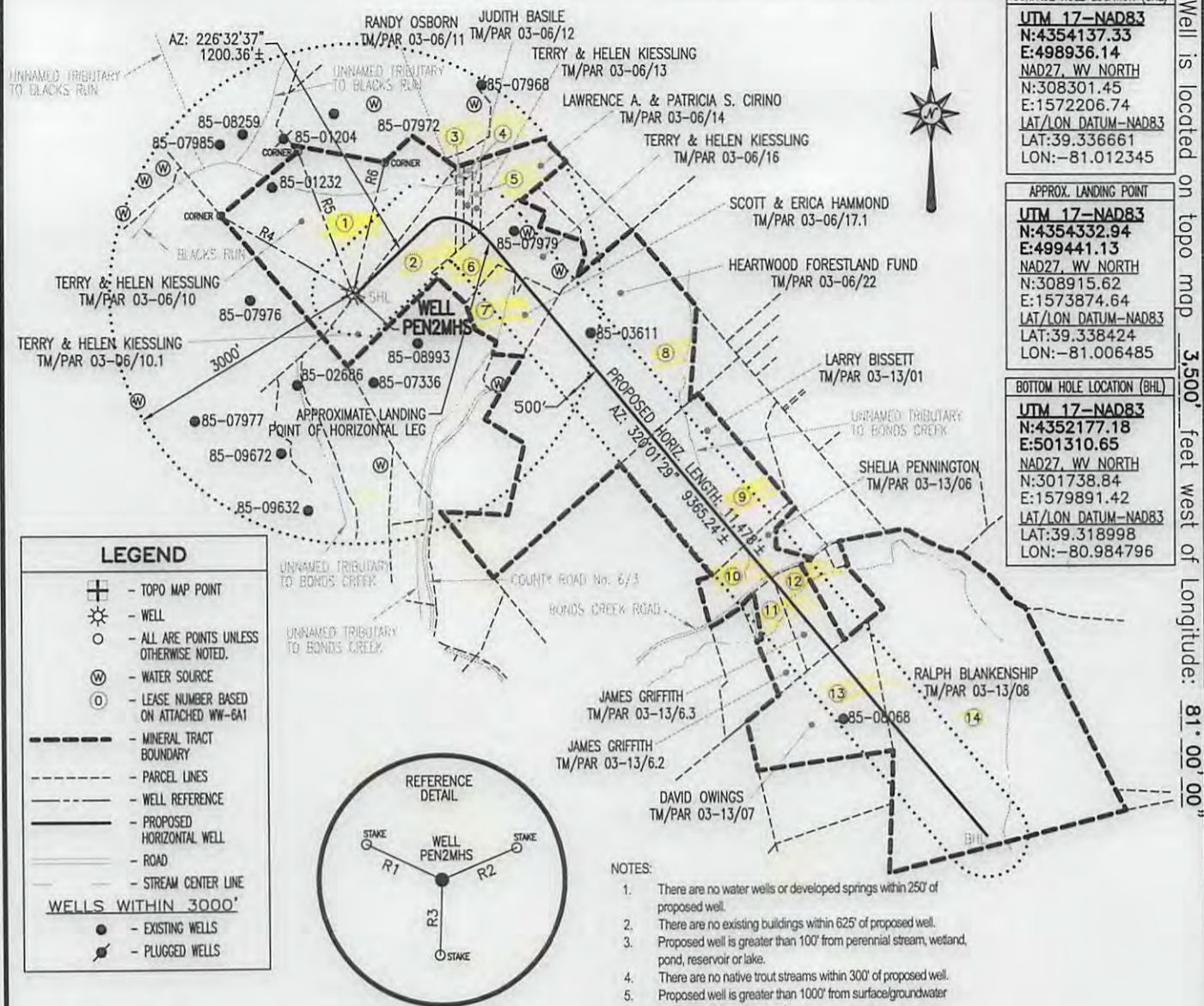

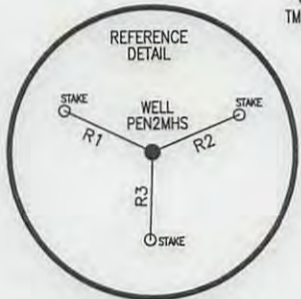

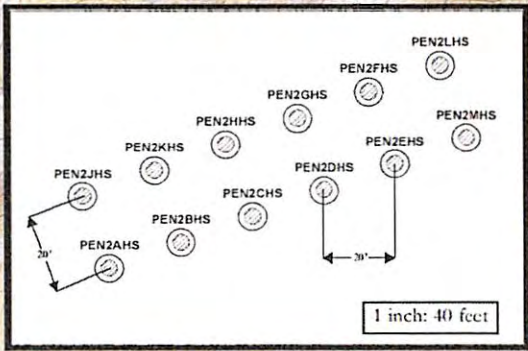

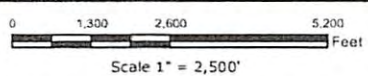
PEN2 SURFACE LOCATIONS
