19) Describe proposed well work, including the drilling and plugging back of any pilot hole:

Drill and complete a new horizontal well in the Marcellus Formation. Drill the vertical to an approximate depth of 6600'. Run open hole logs and plug back with solid cement plug. Kick off and drill curve. Drill the lateral in the Marcellus. Cement casing.

20) Describe fracturing/stimulating methods in detail, including anticipated max pressure and max rate:

Hydraulic fracturing is completed in accordance with state regulations using water recycled from previously fractured wells and obtained from freshwater sources. This water is mixed with sand and a small percentage (less than 0.3%) of chemicals (including 15% Hydrochloric acid, gelling agent, gel breaker, friction reducer, biocide, and scale inhibitor), referred to in the industry as a "slickwater" completion. Maximum anticipated internal casing pressure is expected to be approximately 10000 psi, maximum anticipated treating rates are expected to average approximately 100 bpm. Stage lengths vary from 150 to 300 feet. Average approximately 200,000 barrels of water per stage. Sand sizes vary from 100 mesh to 20/40 mesh. Average approximately 200,000 pounds of sand per stage.

21) Total Area to be disturbed, including roads, stockpile area, pits, etc., (acres): no additional disturbance

22) Area to be disturbed for well pad only, less access road (acres): no additional disturbance

23) Describe centralizer placement for each casing string:

- Surface: Bow spring centralizers – One centralizer at the shoe and one spaced every 500'.
- Intermediate: Bow spring centralizers– One centralizer at the shoe and one spaced every 500'.
- Production: One solid body centralizer spaced every joint from production casing shoe to KOP

Surface: Circulate hole clean while rotating & reciprocating the drill string until cuttings diminish at surface.
Intermediate: Circulate hole clean while rotating & reciprocating the drill string until cuttings diminish at surface.
Production: Pump marker sweep with nut plug to determine actual hole volume. Calculate a gauge holes bottoms up volume. Perform a cleanup cycle by pumping 3-5 bottoms up or until the shakers are clean. Check volume of cuttings coming across the shakers every 15 minutes.

PURCHASE AND SALE AGREEMENT, dated as of May 27, 1999 (this "Agreement"), by and between USX CORPORATION, a Delaware corporation, ("USX") and EQUITABLE RESOURCES, INC., a Pennsylvania corporation (hereinafter referred to as "Buyer").

WHEREAS, USX owns directly or indirectly all of the outstanding capital stock or other evidence of an equity interest of the following companies (each a "Carnegie Company" and collectively the "Carnegie Companies"), which are involved in one or more of the production, gathering, transportation, treatment, distribution and sale of natural gas: (i) Carnegie Natural Gas Company, a Pennsylvania corporation, ("Carnegie"), (ii) Carnegie Interstate Pipeline Company, a Delaware corporation, ("CIPCO"), (iii) Carnegie Production Company, a Pennsylvania corporation, ("CPC"), (iv) Carnegie Natural Gas Sales, Inc., a Delaware corporation, ("CNGS") and (v) Carnegie Gas Storage, LLC, a Delaware limited liability company, ("CGS"); and

WHEREAS, USX desires to sell to Buyer and Buyer desires either for itself and/or one or more designated subsidiaries to purchase from USX one hundred percent (100%) of the capital stock and other evidence of equity interest in the Carnegie Companies;

NOW, THEREFORE, for and in consideration of the premises and the representations, warranties, covenants and agreements herein set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

Section 1.1 The "1935 Act" shall mean the Public Utility Holding Company Act of 1935, as amended.

TOPO QUADRANGLE

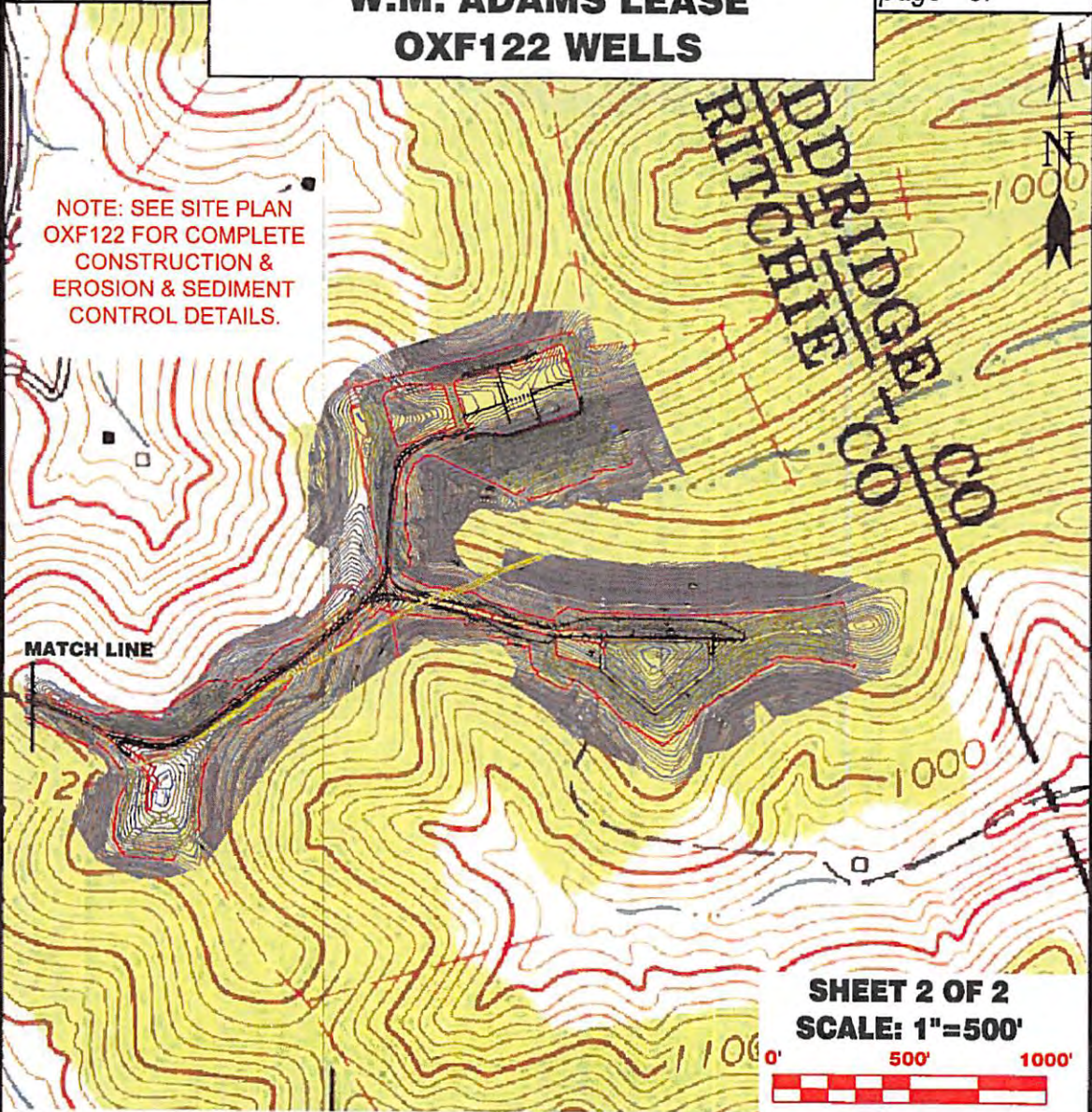

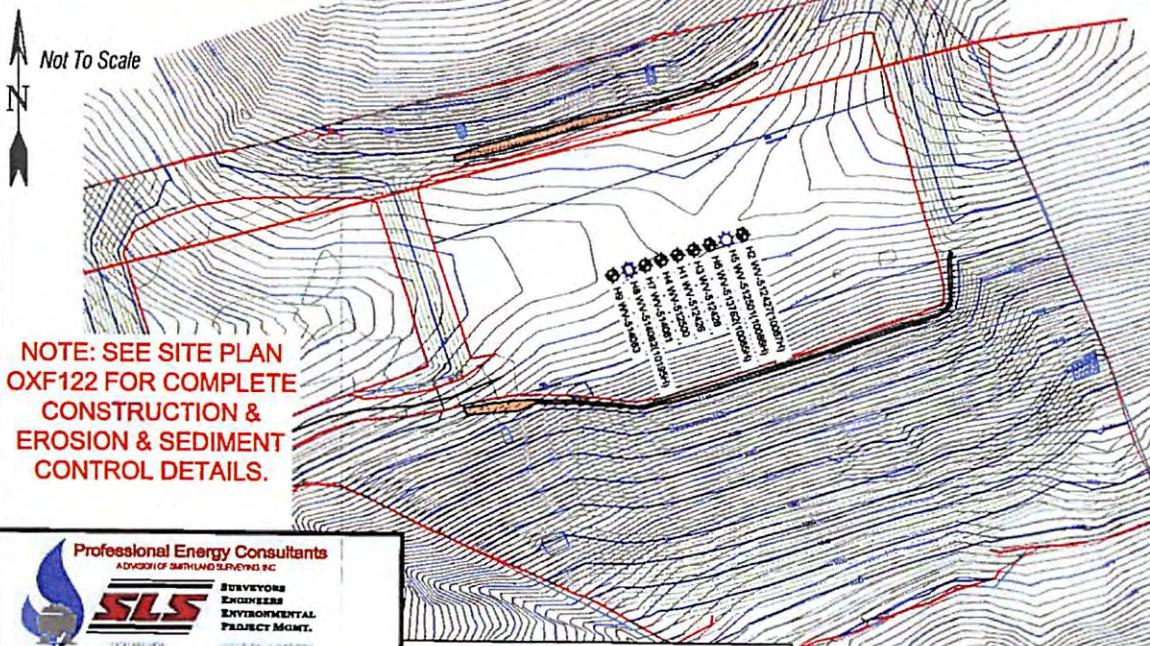
