WELL WORK PLUGGING PERMIT

Plugging

This permit, API Well Number: 47-8702112, issued to CNX GAS COMPANY LLC , is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. The above named operator will also file, as required in WV Code 22-6-23, an affidavit on form WR-38 by two experienced persons in the operator's employment and the Oil and Gas inspector that the work authorized under this permit was performed and a description given. Failure to abide by all statutory and regulatory provisions governing all duties and operations here under may result in suspensions or revocation of this permit and in addition may result in civil and/or criminal penalities being imposed upon the operator.

PERMIT CONDITIONS

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.

CNX Gas - Well DTI 7124

- 1. Verify TD.
- 2. TIH w/ 2-3/8" work string to TD. SPOT GEL.
- 3. Pump bottom cement plug from TD to 1800'.
- 4. TOH w/ 2-3/8" work string. Wait on cement before attempting to pull 6 5/8" casing.
- 5. Attempt to pull 6 5/8" casing and packer from well. If unable to pull, free point and cut above packer. Pull all free 6 5/8" casing.
- 6. TIH w/ 2-3/8" work string to 1750'.
- 7. Pump cement plug from 1750' to 1450' (csg point/cut and water show).

(100' ABOVE SHOT) (SHOT FROM 1849-1862)

- 8. Pull work string to 950'.
- 9. Pump cement plug from 900'-775' (elevation plug).
- 10. Pull work string to 300'.
- 11. Pump cement plug from 300' to surface.
- 12. TOH w/ 2-3/8" work string, and top off cement to surface.
- 13. Install 6" diameter x 14' monument (10' below grade, 4' above grade) API 47-087-02112.






