**WELL WORK PLUGGING PERMIT**

**Plugging**

This permit, API Well Number: 47-9500558, issued to TRIAD HUNTER, LLC, is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. The above named operator will also file, as required in WV Code 22-6-23, an affidavit on form WR-38 by two experienced persons in the operator's employment and the Oil and Gas inspector that the work authorized under this permit was performed and a description given. Failure to abide by all statutory and regulatory provisions governing all duties and operations here under may result in suspensions or revocation of this permit and in addition may result in civil and/or criminal penalties being imposed upon the operator.

## PERMIT CONDITIONS

West Virginia Code §22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

### CONDITIONS

1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
3. Well work activities shall not constitute a hazard to the safety of persons.
4. This well is under a consent order and must be plugged under the terms of that agreement.

## WW – 4B WORK ORDER ATTACHMENT – Plugging Procedure

1. MIRU service rig, pull rods and tubing out of hole, clean hole to total depth, dig pit and install pit liner.
2. Run 2 3/8" 8rd tubing to total depth, pump / set a 250 ft. bottom hole cement plug using Class A Cement, pump gel ahead of cement.
3. Check depth of cement plug, cut casing above cement top and pull casing out of hole.
4. Run 2 3/8" tubing to cut depth and pump / set a 100 ft. cement plug using Class A Cement, pump gel ahead of cement.
5. Pull and set 2 3/8" tubing fifty feet below elevation depth, pump / set a 100 ft. cement plug using Class A Cement, pump gel ahead of cement.
6. Pull and set 2 3/8" tubing 200 feet below surface, pump Class A cement through tubing until cement is circulated to surface.
7. Pull 2 3/8" tubing out of hole and top load hole with Class A Cement.
8. Erect a 3' X 6" monument pipe, fill it with cement, and attach an identification plate to the monument pipe.
9. RDMO service rig and all surface equipment ( tanks, pumping units, casing, ect. ).
10. Remove waste fluids from pit and haul fluids to production yard for solidification.
11. Reclaim location and lease road.
12. Haul solidified waste materials to landfill.

**Time Limits and methods for filing comments.** The law requires these materials to be served on or before the date the operator files his Application. You have **FIVE (5) DAYS** after the filing date to file your comments. Comments must be filed in person or received in the mail by the Chief's office by the time stated above. You may call the Chief's office to be sure of the date. Check with your postmaster to ensure adequate delivery time or to arrange special expedited handling. If you have been contacted by the well operator and you have signed a "voluntary statement of no objection" to the planned work described in these materials, then the permit may be issued at any time.

**Comments must be in writing.** Your comments must include your name, address and telephone number, the well operator's name and well number and the approximate location of the proposed well site including district and county from the application. You may add other documents, such as sketches, maps or photographs to support your comments.

The Chief has the power to deny or condition a well work permit based on comments on the following grounds:

- 1) The proposed well work will constitute a hazard to the safety of persons.
- 2) The soil erosion and sediment control plan is not adequate or effective;
- 3) Damage would occur to publicly owned lands or resources;
- 4) The proposed well work fails to protect fresh water sources or supplies;
- 5) The applicant has committed a substantial violation of a previous permit or a substantial violation of one or more of the rules promulgated under Chapter 22, and has failed to abate or seek review of the violation..."

If you want a copy of the permit as it is issued or a copy of the order denying the permit, you should request a copy from the Chief.

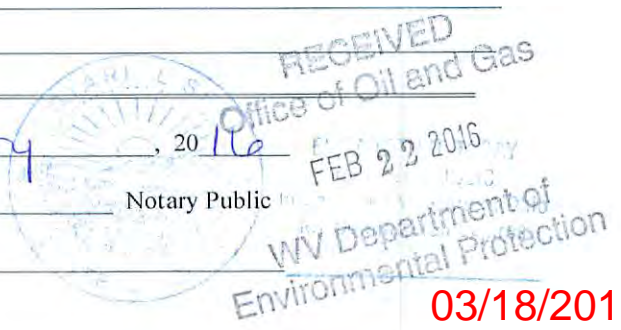

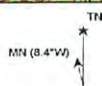
