Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

CONDITIONS

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.
- 4. This well is under a consent order and must be plugged under the terms of that agreement.

Unlimited Energy Services Plug to Abandon Procedure

- 1) Unlimited Energy Services service rig pulls Rods and tubing out of hole.
- 2) Run tubing to a minimum of 50 feet below producing pay zone, pump and set cement plug using class A cement to a minimum of 50 feet above the producing pay zone, pump a 6% gel ahead of the cement.(Cement plug will be a minimum of 100 feet).
- 3) Tag cement top to ensure plug meets minimum, add cement if necessary find free point on casing, cut and remove casing and pull out of the hole.
- 4) Run tubing to a minimum of 50 feet below cut casing. Pump and set cement plug using Class A Cement to a minimum of 50 feet above cut casing, pump a 6% gel ahead of the cement. Pull tubing (Cement plug will be a minimum of 100 feet elevation plug).
- 5) Tag cement top to ensure plug meets minimum, add cement if necessary.
- 6) Pull and set tubing to a minimum of 100 feet below surface, pump Class A cement to surface (minimum of 100 feet surface and fresh water strata plug)
- 7) Erect monument 3 foot by 6 foot with identification number and fill with cement.
- 8) Rig down all equipment. Reclaim location and lease road as necessary. And prepare release forms.

Pursuant to Ohio Revised Code Section 1509.22, the Chief of the Division of Oil and Gas Resources Management ("Chief" or "Division") issues the following Order:

BACKGROUND:

- 1. Mud Masters proposes to operate an oil and gas waste facility to be located at 64036-A Wintergreen Road, Lore City, Ohio in Guernsey County ("Lore City Facility"). The Lore City Facility is a treatment facility that proposes to treat brine or other waste substances associated with the exploration, development, well stimulation, production operations, or plugging of oil and gas resources for lawful disposal. The brine or other waste substances will be treated for the purpose of disposal in an adjacent Class II injection well or if the brine or other waste substances are not suitable for injection, will be stabilized for landfill disposal.
- 2. Division (B)(2)(a) of R.C. 1509.22 states, in pertinent part, that "* * no person shall store, recycle, treat, process, or dispose of in this state brine or other waste substances associated with the exploration, development, well stimulation, production operations, or plugging of oil and gas resources without an order or a permit issued under this section or section 1509.06 or 1509.21 of the Revised Code or rules adopted under any of those sections."

3. On October 30, 2015, the Division received an application from Mud Masters requesting to temporarily store, treat, and process brine and other waste substances associated with the exploration, development, well stimulation, production operations, or plugging of oil and gas resources at the Lore City Facility. In its application, Mud Masters supplied the Division with information and details regarding its proposed operations. The Lore City Facility will accept liquid and semi-solid oilfield wastes for the purpose of treating them for disposal. Those waste materials suitable for disposal in a Class II underground injection well will be treated prior to pumping them to an adjacent injection well for disposal. The material not suitable for underground injection will be stabilized and tested prior to RECEIVED transportation to a landfill for lawful disposal.

IT IS HEREBY ORDERED:

WV Department of Environmental Protection

Mud Masters has temporary approval at the Lore City Facility to temporarily store, treat, and process brine or other oilfield waste substances associated with the exploration, development, well stimulation, production operations, or plugging of oil and gas resources, subject to the following conditions:

- 1. Mud Masters shall conduct all operations at the Lore City Facility in compliance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9.
- 2. Brine shall not be disposed of in a manner not specified in R.C. 1509.22(C)(1)(a) through R.C. 1509.22(C)(1)(c). Disposal of brine pursuant to R.C. 1509.22(C)(1)(d) requires separate written approval by the Chief.
- 3. Mud Masters shall conduct all operations at the Lore City Facility in accordance with the application submitted to the Division for this facility. Mud Masters shall notify the Division prior to implementing any changes in operations at the Lore City Facility.
- 4. Mud Masters shall stabilize oilfield waste substances by adding quick-lime, Portland cement, or an alternate stabilization agent approved by the Chief, if the waste substance is to be disposed of in this state at a licensed solid waste landfill. If the waste substance is to be transported or disposed of out of state, Mud Masters shall comply with all applicable state and federal laws.
- 5. Mud Masters shall implement the Radiological Protection Plan ("RPP") submitted to the Division with the application for the Lore City Facility and shall continuously update the protocols and procedures in accordance with the plan.
- 6. Not later than one year after the date of this order, Mud Masters shall perform a radiation and contamination survey of the Lore City Facility, including the on-site vessels and equipment, to determine if there is a need to modify the procedures and protocols in the RPP

to ensure the protection of its employees, contractors, and the public health and safety as well as the environment. Any modifications of the RPP will be incorporated and made a part of this order and Mud Masters shall operate the Lore City Facility in accordance with the modified plan.

- 7. Mud Masters shall maintain waste and material management records for Lore City Facility and provide those records to the Division upon request. The records shall include, but not be limited to, manifests of all incoming oilfield waste substances and the final disposition of all the outgoing oilfield waste substances.
- 8. Mud Masters shall notify the Division at least 14 days before terminating operations at the Lore City Facility.
- 9. Mud Masters shall remediate any brine or other waste substances associated with the exploration, development, well stimulation, production operations, or plugging of oil and gas resources that is released in ground water or in or on the land or discharged in surface water as a result of the operations at the Lore City Facility.
- 10. This Chief's Order shall terminate upon any of the following, whichever occurs first:
 - a) The Division issues a permit to Mud Masters for the Lore City Facility pursuant to rules promulgated under to R.C. 1509.22(C);
 - b) The Division denies a permit to Mud Masters for the Lore City Facility pursuant to rules promulgated under R.C. 1509.22(C); or
 - c) Six months after the effective date of rules adopted under R.C. 1509.22(C):
 - d) The location of the Lore City Facility changes from 64036-A Wintergreen Road, Lore City, Ohio.

e) The ownership of the Lore City Facility changes from Mud Masters.

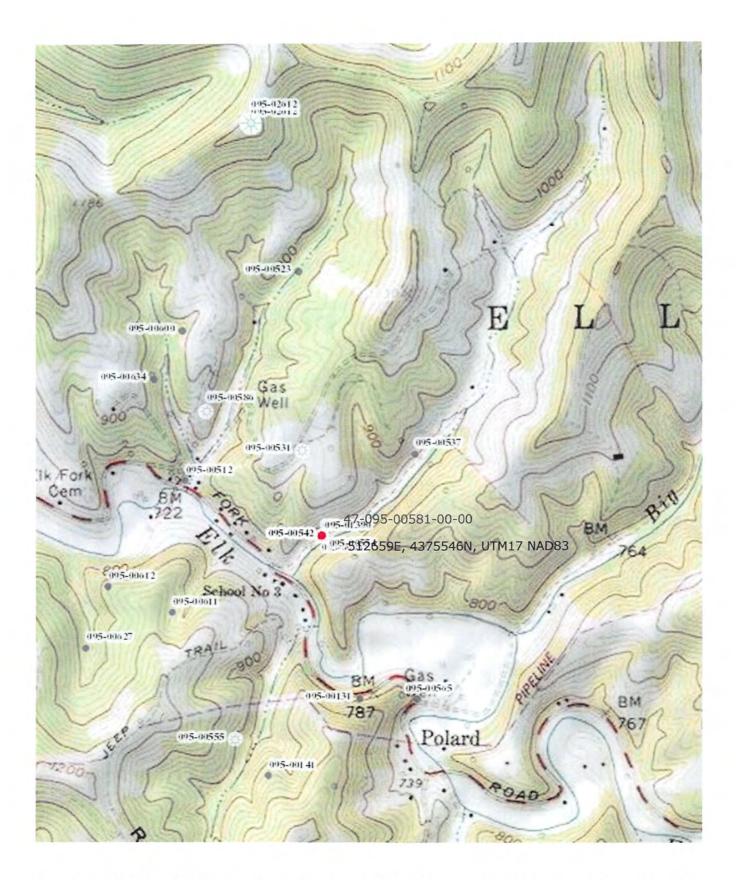
