**WELL WORK PERMIT**

This permit, API Well Number: 47-9502291, issued to BOWYER, DAVID, is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Please be advised that form WR-35, Well Operators Report of Well Work is to be submitted to this office within 90 days completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

In addition to the applicable requirements of this permit, and the statutes and rules governing oil and gas activity in WV, this permit may contain specific conditions which must be followed. Permit conditions are attached to this cover letter.

## PERMIT CONDITIONS

West Virginia Code §22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

### CONDITIONS

---

1. If the operator encounters an unanticipated void, or an anticipated void at an unanticipated depth, the operator shall notify the inspector within 24 hours. Modifications to the casing program may be necessary to comply with W. Va. Code §22-6-20, which requires drilling to a minimum depth of thirty feet below the bottom of the void, and installing a minimum of twenty (20) feet of casing. Under no circumstance should the operator drill more than fifty (50) feet below the bottom of the void or install less than twenty (20) feet of casing below the bottom of the void.
2. Pursuant to 35 CSR 4-19.1.a, at the request of the surface owner all water wells or springs within 1000 feet of the proposed well that are actually utilized for human consumption, domestic animals or other general use shall be sampled and analyzed.
3. Pursuant to 35 CSR 4-19.1.c, if the operator is unable to sample and analyze any water well or spring with one thousand (1,000) feet of the permitted well location, the Office of Oil and Gas requires the operator to sample, at a minimum, one water well or spring located between one thousand (1,000) feet and two thousand (2,000) feet of the permitted well location.
4. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
5. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
6. During the surface casing and cementing process, in the event cement does not return to the surface, or any other casing string that is permitted to circulate cement to the surface and does not return to the surface, the oil and gas inspector shall be notified within twenty-four (24) hours
7. Well work activities shall not constitute a hazard to the safety of persons.
8. Operator shall provide the Office of Oil & Gas notification of the date that drilling commenced on this well. Such notice shall be provided by sending an email to DEPOOGNotify@wv.gov within 30 days of commencement of drilling.

NOTICE TO SURFACE OWNERS

The well operator named below is preparing to file for a permit from the state to drill a new well. Pursuant to your request, and for the purposes of this Original Drilling Title Opinion, I have examined title to the real property described in the instruments of record in the Office of the Clerk of the County Commission of Tyler County, West Virginia in **Deed Book 420, Page 623**, being that tract appearing on the property tax records of Ellsworth District, of said county and state, as Map 16, Parcel 6, covering the period of time from January 1, 1830, to June 17, 2015 at 4:00 p.m.

For purposes requiring an exact legal description, the tract in question may be described as follows:

### **COMMENTS, REMARKS AND REQUIREMENTS**

1. I note that this title does not cover questions of vacancies, excess or deficiencies, boundaries, encroachments, uses not of record, environmental issues, or other matters that would be revealed by a survey of visual inspection of the premises. I recommend that an accurate survey of the Subject Tract and all related outsales, easements and rights of way, be obtained prior to mining, improving or using the Subject Property for the following reasons:

It is the intention of David Bowyer to build a pit capable of holding no more than 5,000 BBL of fresh water to be used in the fracturing of well Croasmun #1. This pit will be built separate of the drilling pit and will be used in a temporary manner. The walls will be compacted as needed to ensure a stable structure and a liner will be used in the pit. The pit will be used and filled with fresh water then used as expeditiously as possible to fracture the well. Following fracturing the well, the flowback will be completed and once the flowback has been completed, all flowback water shall be hauled from this pit to an injection facility for disposal. Once the pit has been dried out, reclamation will ensue. It is the intention of David Bowyer to use this pit as a temporary structure and not a long standing impoundment.

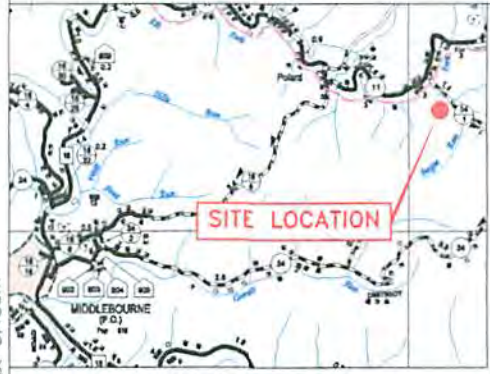

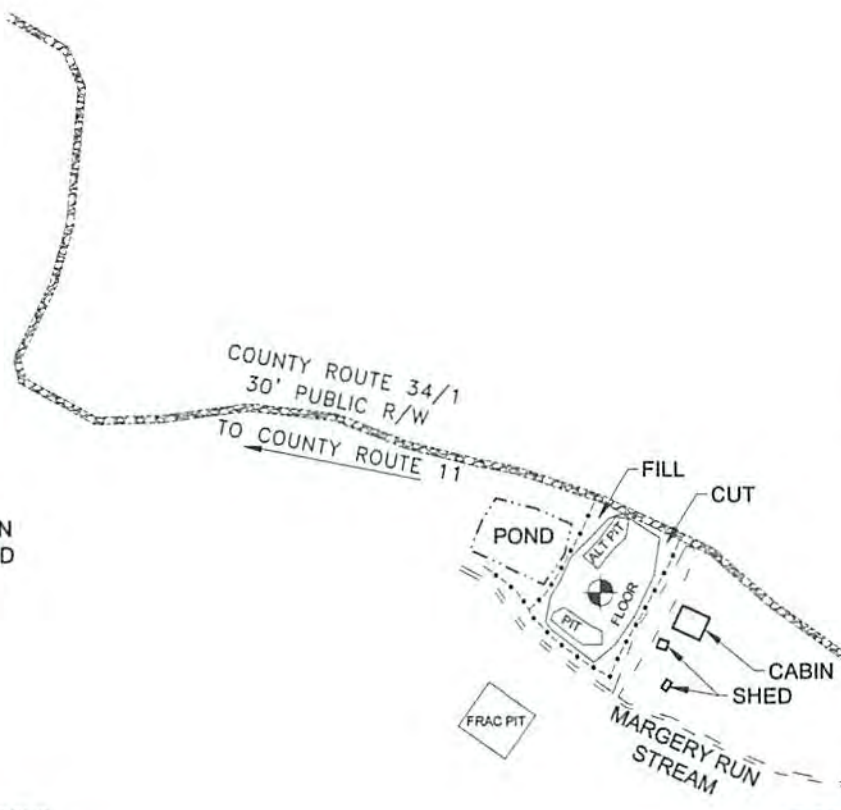
## HENRY CROASMUN WELL SITE

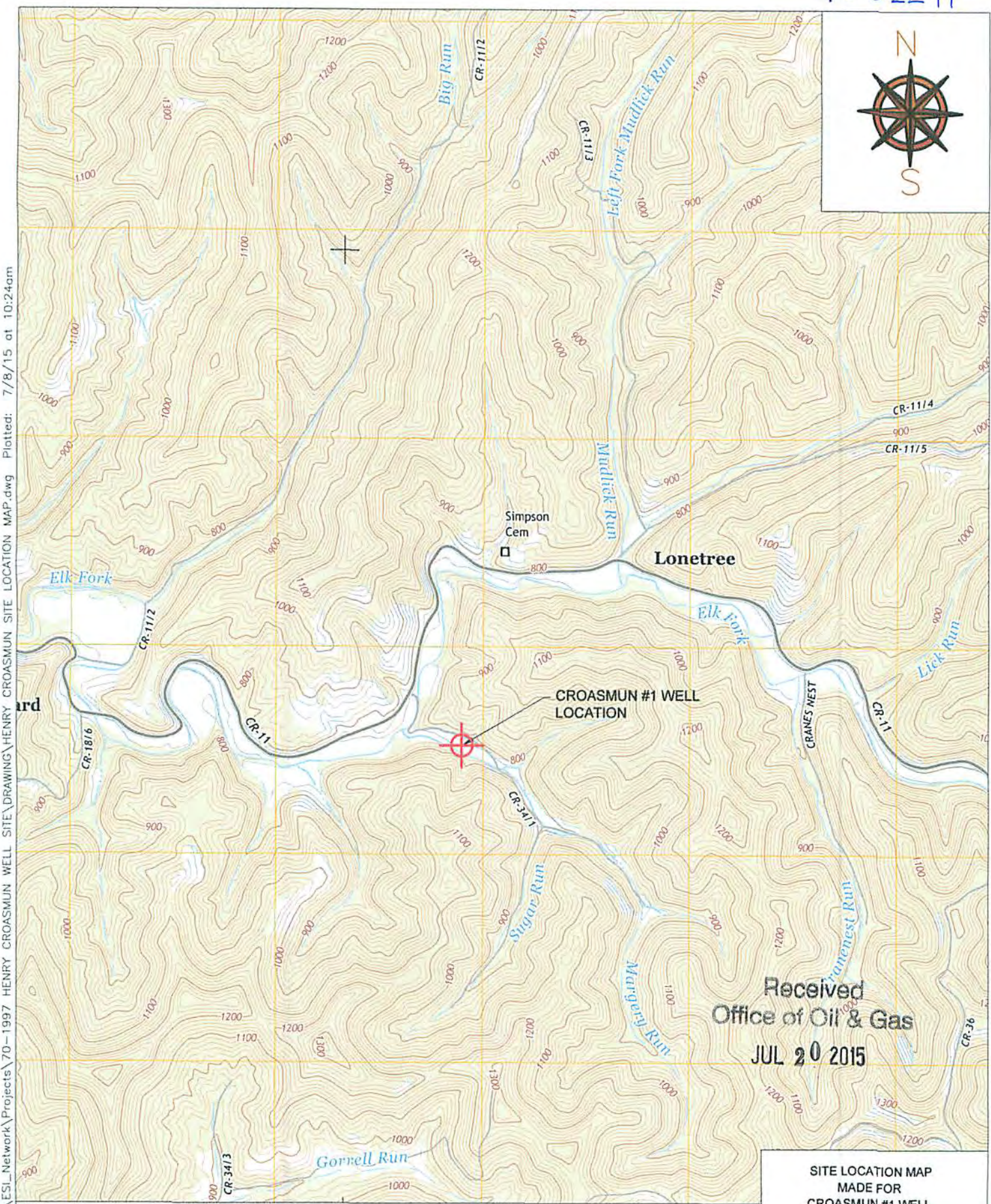

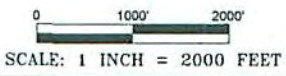
