Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.

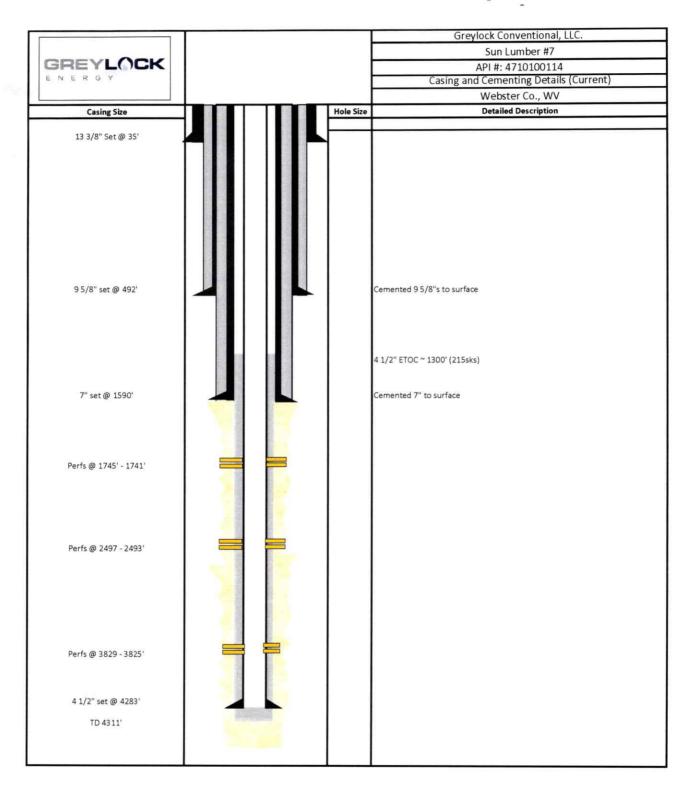


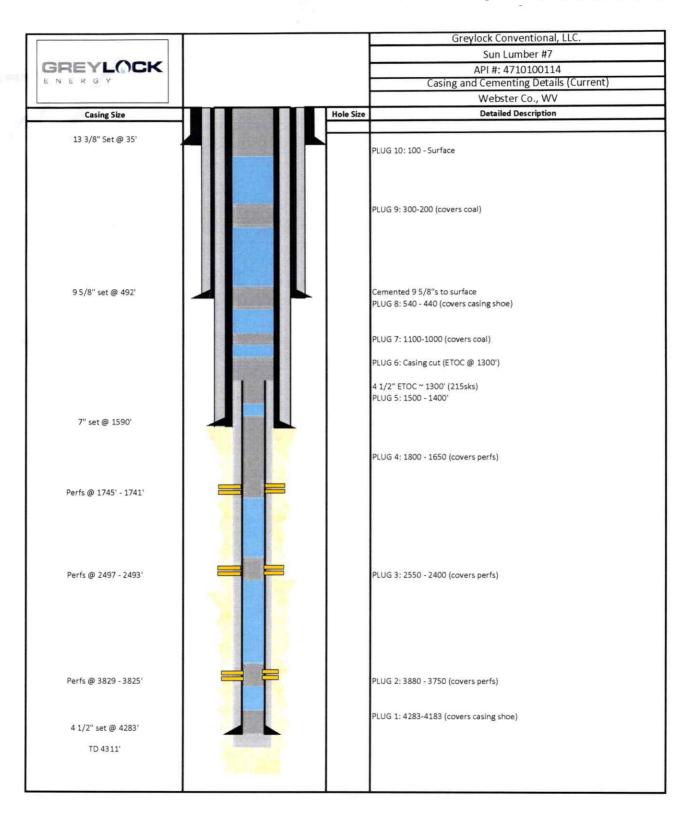

- 1. Notify the inspector at least 24 hours prior to conducting abandonment operations.
- 2. Blow down well
- 3. POOH with Tubing, RIH and confirm TD and fill depth.
- 4. Prep for cement. NOTIFY INSPECTOR OF TAG DEPTH
- 5. Lead with gel spacer on ALL cement plugs
- PLUG 1 –Set cement plug from <u>Approved Tag Depth -4183'</u> to cover casing shoe located 4283'.
- 7. PLUG 2 PUH and set balance plug from 3880 3750' to cover perfs @ 3825'
- 8. PLUG 3 PUH and set balance plug from 2550' 2400' to cover perfs @ 2493'
- PLUG 4 PUH and set balance plug from <u>1800' 1540'</u> to cover perfs @ 1741' and casing shoe @ 1590'
- 10. PLUG 5 PUH and set balance plug from 1500 1400' to cover salt water
- 11. Free point 4.5" casing, rip and pull pipe. Note: Pull pipe after cement plugs below are set
- 12. PLUG 6 casing cut Set 100' plug across casing cut. ETOC @ 1300'
- 13. PLUG 7 PUH and set balance plug from 1100'-1000' to cover coal zone @ 1050'
- 14. PLUG 8 PUH and set balance plug from 540' 440' to cover casing shoe
- 15. PLUG 9 PUH and set balance plug from 300' 200' to cover coal zones
- 16. PLUG 10 PUH and set balance plug from 100'-surface to cover surface plug
