Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.

- 2. We will try to plug well in place without a rig on the hole and tubing will be left in the well and cemented with solid cement to surface perforating 2" tubing up the hole.
- 3. TIH wireline, perforate 2" tbg @ 2680'.
- Establish circulation, pump C1A cement plug from 2680' to 2280'.(gas show, packer)
- 5. Check TD inside tbg, if @ 2280', proceed to next step.
- 6. TIH wireline perforate 2" tbg, @ 2275'.
- 7. Establish circulation, pump C1A cement plug from 2275' to 1800'. (6 5/8" casing seat).
- 8. Check TD inside tbg, if @ 1800', proceed to next step.
- 9. TIH wireline to 1795' perforate 2" tbg & 6 5/8" csg. (2 holes).
- 10. Establish circulation, pump C1A cement plug from 1795'to 950'
- 11. Check TD inside tbg, if @ 950', proceed to next step
- 12. TIH wireline to 945' perforate 2" tbg & 6 5/8" casing, (2 holes).
- 13. Establish circulation, pump C1A cement plug, 945' to 500', (elevation, coal, 8 1/4" casing seat, 10" casing seat).
- 14. Check TD inside tbg if @ 500', proceed to next step

Per our conversations about the above referenced well, this well is situated in the yard area of an Equitrans compressor station.

Due to the proximity of the facilities surrounding the well, i.e., pipe lines, valve settings, tanks etc. there is not enough space to get a rig and support equipment onsite to perform our normal plugging process for a well.

Therefore, we ask that the DEP, allow us to "plug in place" the well with the procedure outlined in the plugging permit application that we have submitted.

The intent is to perforate all tubing's, casings in the well with deep penetrator ball type shots and completely fill the well bore with Type 1 (Class A) cement.

This process will be done in a step by step manner by setting a 600'plug, give curing time, tag plug and set additional 600' plugs immediately on top of previous plug(s) to surface.




