

# TERMS AND CONDITIONS

In consideration of the prices to be charged as set forth in Dowell's Published Price Schedule and the performance of services and supplying of materials, customer agrees to the following terms and conditions:

- 1. TERMS. Cash in advance unless satisfactory credit is established; on credit sales to pay total net billing price at Dowell's office, Tulsa, Oklahoma by the end of the month following the month of treatment or sale. On past-due accounts, to pay interest thereon at the prime (New York) rate (in effect at time account becomes past due) plus one percent (1%). In the event it is necessary to employ an attorney to enforce collection of such account, customer agrees to pay all collection costs and attorney's fees in the amount of 20% of said account.
- 2. TAXES. Any tax based on or measured by the charge for sale or rental of products or rendering of service shall be added to the price stated in Dowell's price schedule.
- 3. PRODUCT SALES & RENTALS WARRANTY. Dowell warronts only that products (including tools, supplies and materials) furnished shall conform to the quality and specification represented and that Dowell can convey good title; DOWELL MAKES NO WARRANTY OF MERCHANTABILITY, OR THAT SAID PRODUCTS SHALL BE FIT FOR ANY PARTICULAR PURPOSE, NOR IS THERE ANY OTHER WARRANTY EXPRESSED OR IMPLIED EXCEPT AS EXPRESSLY STATED HEREIN.

Dowell's liability and customer's exclusive remedy for any cause of action arising out of a product sale or rental pursuant hereto is expressly limited at Dowell's option to (a) replacement of such product upon its return to Dowell, or (b) allowance to customer of credit for the cost of such product.

- 4. DOWN-HOLE TOOLS, EQUIPMENT & INSTRUMENTS.
  - o. If tools, equipment or instruments of Dowell are lost in a well, customer agrees to make a reasonable effort at customer's risk and expense to recover same; and, if unable to recover, to pay Dowell for same unless such loss or damage was caused solely by Dowell's negligence.
  - b. Unless caused by Dowell's willful misconduct or failure to exercise good faith. Dowell shall not be liable for and customer shall secure Dowell against any liability for damage to property of customer (and well owner if different from customer) resulting, directly or indirectly, from tools, equipment or instruments of Dowell being lost in a well.
- 5. DOWELL SERVICES. In rendering any service ordered by the customer, Dowell shall be an independent contractor with the understanding, however, that customer has complete custody and control of the well, the conditions created in the well, the drilling equipment, well premises and access routes from highways to well locations. Customer will give Dowell reasonable notice for each service ordered and, if requested, will furnish Dowell with written order for the same. Customer will have the well in readiness for the service and, following service, will return well to production.

A reasonable attempt will be made to get from the highway to the location and back under Dowell's own power. If caterpillar or other towing equipment is required, same will be provided by customer at his expense. If customer does not provide towing equipment, when necessary, Dowell will obtain same and bill customer at actual cost. In interpreting well information and making recommendations, either written or oral, as to type or amount of material or service to be

Nevertheless, all such recommendations or predictions are opinions only; and, in view of the impractibility of obtaining first-hand knowledge of the many variable well conditions and the necessity of relying on facts and supporting services furnished by others, NO WARRANTY IS GIVEN CONCERNING THE EFFECTIVENESS OF THE MATERIALS USED, RECOMMENDATIONS GIVEN, OR THE SERVICES RENDERED.

#### 6. CUSTOMER'S RESPONSIBILITY & INDEMNITIES.

- a. Unless caused by Dowell's willful misconduct or failure to exercise good faith, customer agrees to be fully responsible for and secure Dowell against:
  - Liability for damage to property of customer (and well owner if different from customer), this provision applying to but not limited to subsurface damage and surface damage orising from subsurface damage;
  - (ii) Liability for reservoir loss or damage, or any property damage or personal injuries resulting directly or indirectly from subsurface pressure, well blowout or cratering, or losing control of the well;
  - (iii) Liability for any damages whatever, resulting directly or indirectly from a subsurface tresposs arising out of any servicing operation performed by Dowell for customer;

Customer, shall furnish water transportation for crew changes.

Special jobs, under unusual conditions, will be subject to special price quotations to reflect increased or reduced costs.

In consideration of the prices hereinafter set out, it is understood that the services offered by us are to be performed only under the following terms and conditions:

- 1. All prices are exclusive of any Federal, State or Special taxes imposed on the sale or use of the merchandise and services listed, which taxes will be added to quoted prices where applicable. A 5% royalty will be added where applicable.
- 2. In the event any of our instruments or equipment is lost in the well, Customer shall either recover same without cost to us, or pay for such instruments or equipment. In case it is necessary for Customer to "fish" for any of our instru-ments or equipment, Customer assumes the entire responsibility for such operations. None of our employees is authorized to do anything other than advise and consult with Customer in connection with such "fishing" operations, and any "fishing" tools furnished by us are furnished solely as an accommodation to Customer, and we shall not be liable or responsible for any damage that Customer may incur or sustain through their use or by reason of any advice or assistance rendered to Customer by our agents or employees, irrespective of cause.
- 8. We endeavor to design and maintain our equipment to safely service properly drilled and conditioned wells. We carry public liability and property damage insurance. As there are so many conditions in and around wells which are uncertain and unknown and not subject to our control, we can neither guarantee the results nor be liable for injuries to property or persons for loss or damage arising from the performance of our services or resulting therefrom.
- 4. A reasonable attempt will be made by us to get from the highway to the location and back again under our own power. If tractors or other types of equipment or services are required to give us access to or return from the well location, same will be provided by the Customer at his expense.
- 00 0 5. In making any interpretation of logs our employees will give Customer the benefit of their best judgment as to the correct interpretation. Nevertheless, since all interpretations are opinions based on inferences from electrical or other measurements, we cannot, and do not, guarantee the accuracy or correctness of any interpretation, and we shall not be liable or responsible for any loss, costs, damages or expenses incurred or sustained by Customer resulting from any interpretation made by any of our officers, agents, or employees.

- 6. Customer acknowledges that he is aware of the facts that: the radioactive source used in neutron logging is potentially dangerous to humans and animals; should the neutron source be lost in the well bore that special precautions must be taken in "fishing" in order that the container of the neutron source is not broken or damaged; the neutron source, if not recovered, must be isolated by cementing it in place or by some other appropriate means that is in agreement with the policy of the Atomic Energy Commission pertaining to the situation.
- 7. On jobs where our equipment is transported by a conveyance belonging to, or arranged for by the Customer, the Customer shall be responsible for the undamaged and safe return to the point of embarkation (or a point easily accessible to the point of embarkation) of all our equipment.

In accepting an order to perform or attempt to perform any service involving the use of radioactive material, we do so with the understanding that: we do not guarantee results, and shall not be liable or responsible for injury to or death of persons or damage to property (including, but not limited to, injury to the well), or any damages whatsoever, irrespective of the cause, growing out of or in any way connected with the use of radioactive material, and the Customer shall absolve and hold us harmless against all liability for any and all loss, costs, damages, and expenses incurred or sustained by Customer or any third party, irrespective of the cause, resulting from any use of radioactive material in the rendering of our services.
  - 9. Information derived by us in rendering our services will be held in strict confidence and will be released only upon written approval of the Customer.
  - 10. The Customer will have a responsible representative present to issue orders relative to the service or services to be performed.

In consideration of the prices to be charged as set forth in Dowell's Published Price Schedule" and the performance of services and supplying of materials, customer agrees to the following terms and conditions:

- 1. TERMS. Cash in advance unless satisfactory credit is established; on credit sales to pay total net billing price at Dowell's office, Tulsa, Oklahoma by the end of the month following the month of treatment or sale. On past-due accounts, to pay interest thereon at the prime (New York) rate (in effect at time account becomes past due) plus one percent (1%). In the event it is necessary to employ an attorney to enforce collection of such account, customer agrees to pay all collection costs and attorney's fees in the amount of 20% of said account.
- 2. TAXES. Any tax based on or measured by the charge for sale or rental of products or rendering of service shall be added to the price stated in Dowell's price schedule.
- 3. PRODUCT SALES & RENTALS WARRANTY. Dowell warrants only that products (including lools, supplies and materials) furnished shall conform to the quality and specification represented and that Dowell can convey good title; DOWELL MAKES NO WARRANTY OF MERCHANTABILITY, OR THAT SAID PRODUCTS SHALL BE FIT FOR ANY PARTICULAR PURPOSE, NOR IS THERE ANY OTHER WARRANTY EXPRESSED OR IMPLIED EXCEPT AS EXPRESSLY STATED HEREIN.

Dowell's liability and customer's exclusive remedy for any cause of action arising out of a product sale or rental pursuant hereto is expressly limited at Dowell's option to (a) replacement of such product upon its return to Dowell, or (b) allowence to customer of credit for the cost of such product.

- 4. DOWN-HOLE TOOLS, EQUIPMENT & INSTRUMENTS.
  - a. If tools, equipment or instruments of Dowell are lost in a well, customer agrees to make a reasonable effort at customer's risk and expense to recover same; and, if unable to recover, to pay Dowell for same unless such loss or damage was caused solely by Dowell's negligence.
  - b. Unless caused by Dowell's willful misconduct or failure to exercise good faith, Dowell shall not be liable for and customer shall secure Dowell against any liability for damage to property of customer (and well owner if different from customer) resulting, directly or indirectly, from tools, equipment or instruments of Dowell being lost in a well.
- 5. DOWELL SERVICES. In rendering any service ordered by the customer, Dowell shall be an independent contractor with the understanding, however, that customer has complete custody and control of the well, the conditions created in the well, the drilling equipment, well premises and occess routes from highways to well locations. Customer will give Dowell reasonable notice for each service ordered and, if requested, will furnish Dowell with written order for the same. Customer will have the well in readiness for the service and, following service, will return well to production.

A reasonable attempt will be made to get from the highway to the location and back under Dowell's own power. If caterpillar or other towing equipment is required, same will be provided by customer at his expense. If customer does not provide towing equipment, when necessary, Dowell will obtain same and bill customer at actual cost. In interpreting well information and making recommendations, either written or oral, as to type or amount of material or service to be

furnished, or manner of performance, or in predicting results to be obtained therefrom, Dowell will give customer the benefit of its best judgment based on its experience in the field. Nevertheless, all such recommendations or predictions are opinions only; and, in view of the impractibility of obtaining first-hand knowledge of the many variable well conditions and the necessity of relying on facts and supporting services furnished by others, NO WARRANTY IS GIVEN CONCERNING THE EFFECTIVENESS OF THE MATERIALS USED, RECOMMENDATIONS GIVEN, OR THE SERVICES RENDERED.

#### 6. CUSTOMER'S RESPONSIBILITY & INDEMNITIES.

- a. Unless caused by Dowell's willful misconduct or failure to exercise good faith, customer agrees to be fully responsible for and secure Dowell against:
  - (i) Liability for damage to property of customer (and well owner if different from customer), this provision applying to but not limited to subsurface damage and surface damage orising from subsurface damage;
  - (ii) Liability for reservoir loss ar damage, or any property damage or personal injuries resulting directly or indirectly from subsurface pressure, well blawout or cratering, or lasing control of the well;
  - (iii) Liability for any demages whatever, resulting directly or indirectly from a subsurface tresposs arising out of any servicing operation performed by Dowell for customer:
  - (iv) Liability for injury to persons (including death) or damage to property, other than employees and property of Dowell, growing out of or in any way connected with the use of materials in the well which are radioactive, poison, toxic or otherwise hazardous.
- b. Customer agrees that it occupies an equal bargaining position with Dowell and that the contractual liability assumed hereunder by customer is reasonable and equitable based on the nature of the services to be performed by Dowell.
- 7. OFFSHORE EQUIPMENT & MARINE OPERATIONS. In addition to the foregoing terms and conditions, which are applicable to offshore marine operations as well as land operations, customer ogrees to insure against loss and assumes full responsibility for damage to equipment furnished by Dowell, including truck or skid-mounted pumpers, mixers, compressors, and auxiliary equipment from time of delivery to customer at landing until returned to landing when transported on craft, or located on platforms not owned or leased by Dowell.

Customer shall furnish water transportation for crew changes.

8. PRICE CHANGES. All prices appearing in said Price Schedule are subject to change without notice.

Prices in this schedule apply to regular and usual jobs and operations. Special jobs, under unusual conditions, will be subject to special price quotations to reflect increased or reduced costs.

9. The term "Dowell" as used herein is a trade name of The Dow Chemical Company; and, where used throughout this agreement, shall be construed to mean The Dow Chemical Company and its Dowell Division.

No Employee other than an Authorized Officer of Dowell is empowered to offer the above Terms and Conditions.



In consideration of the prices to be charged as set forth in Dowell's Published Price Schedule and the performance of services and supplying of materials, customer agrees to the following terms and conditions:

- 1. TERMS. Cash in advance unless satisfactory credit is established; on credit sales to pay total net billing price at Dowell's office, Tulsa, Oklahoma by the end of the month following the month of treatment or sale. On past-due accounts, to pay interest thereon at the prime (New York) rate (in effect at time account becomes past due) plus one percent (1%). In the event it is necessary to employ an attorney to enforce collection of such account, customer agrees to pay all collection costs and attorney's fees in the amount of 20% of said account.
- 2. TAXES. Any tax based on or measured by the charge for sale or rental of products or rendering of service shall be added to the price stated in Dowell's price schedule.
- 3. PRODUCT SALES & RENTALS WARRANTY. Dowell warrants only that products (including lools, supplies and materials) furnished shall conform to the quality and specification represented and that Dowell can convey good title; DOWELL MAKES NO WARRANTY OF MERCHANTABILITY, OR THAT SAID PRODUCTS SHALL BE FIT FOR ANY PARTICULAR PURPOSE, NOR IS THERE ANY OTHER WARRANTY EXPRESSED OR IMPLIED EXCEPT AS EXPRESSLY STATED HEREIN.

Drowell's liability and customer's exclusive remedy for any cause of action arising out of a product sale or rental pursuant hereto is expressly limited at Dowell's option to (a) replacement of such product upon its return to Dowell, or (b) allowance to customer of credit for the cost of such product.

Unless caused by Dowell's willful misconduct or failure to exercise good faith, Dowell shall not be liable for and customer shall secure Dowell against any liability for damage to property of customer (and well owner if different from customer) resulting, directly or indirectly, from tools, equipment or instruments of Dowell being lost in a well.
- 5. DOWELL SERVICES. In rendering any service ordered by the customer, Dowell shall be an independent contractor with the understanding, however, that customer has complete custody and control of the well, the conditions created in the well, the drilling equipment, well premises and access routes from highways to well locations. Customer will give Dowell reasonable notice for each service ordered and, if requested, will furnish Dowell with written order for the same. Customer will have the well in readiness for the service and, following service, will return well to production.

A reasonable attempt will be made to get from the highway to the location and back under Dowell's own power. If catespillar or other towing equipment is required, same will be provided by customer at his expense. If customer does not provide towing equipment, when necessary, Dowell will obtain same and bill customer at actual cost. In Interpreting well information and making recommendations, either written or oral, as to type or amount of material or service to be

furnished, or manner of performance, or in predicting results to be obtained therefrom, Dowell will give customer the benefit of its best judgment based on its experience in the field. - 6. CUSTOMER'S RESPONSIBILITY & INDEMNITIES.
  - u. Unless caused by Dowell's willful misconduct or failure to exercise good faith, customer agrees to be fully responsible for and secure Dowell against:
    - (i) Liability for damage to property of customer (and well owner if different from customer), this provision applying to but not limited to subsurface damage and surface damage arising from subsurface damage;
